The new rates begin with the billing for Sept. thru Dec. quarter and will appear on the Jan. 1, 2013 bills.**

The BRF is based on the number of EDU's and the total average daily water consumption. Minimum BRF will be **\$15.00** per quarter/**\$60.00** for a year. The fees is collected by the Town of Denton and paid to the State of Maryland.  All Utility Bills are issued quarterly on the 1st of January, April, July and October and are due on the 25th of the month billed. 1% Interest is added monthly for any past due balances. Water service is turned off for delinquent accounts approximately 15 days after the due date. Delinquent account balances are considered a lien on the property and subject to the annual property tax sale process.
