PROCEEDINGS

1	The meeting was called to order by Chairperson Mackel at 6:00 p.m. in the Denton Town
2	Conference Room.
3	Pledge of Allegiance
4	Introduction of panel and staff. The minutes of March 18, 2009, Historic Review Meeting
5	were accepted as presented.
6	Other Old Business – None.
7	$\underline{\text{New Business } \#1 - B^2 \text{ Driver Improvement Center/Sign}} - \text{Bobby Crossling and Robert El}$
8	made the presentation to install signage at 217 Market Street. Applicants have leased space for a
9	driver improvement education program.
10	Ms. Jones motioned to approve the window signage as submitted in the application.
11	Mr. Peterson seconded the motion. All Aye. Motion carried.
12	New Business #2 – Dennis & Maria Weaver/Fence – Dennis & Maria Weaver and Kurt Gant
13	made the presentation to replace the fence at 113 S. 5 th Avenue. The existing fence encroaches on
14	the neighbor's property and will be removed and replaced on the Weaver's property. The proposed
15	fence exceeds the 7' height allowed in the Denton Town Code. Applicant revised the fence
16	removing the lattice creating a 7' solid popolar board fence.
17	Ms. Jones motioned to approve a 7' solid white popolar board fence without lattice.
18	Mr. Dowdall seconded the motion. All Aye. Motion carried.
19	Other New Business #3 – Daniel Wroe/Rehab – Daniel Wroe made the presentation for the
20	proposed renovations at 108 N. 6 th Street. Proposed exterior renovations include trim replacement,
