1	Call to Order:
2	The Historic and Architectural Review Commission Meeting was called to order
3	by Chairperson Mackel, at 6:00 p.m., on March 17, 2021, at the Denton Town Office,
4	leading everyone in the Pledge of Allegiance.
5	This Meeting was made available to the public via Zoom Video Conferencing and
6	access to the meeting was made available on the Town website.
7	<u>Approval of Minutes:</u>
8	The minutes of the November 18, 2020, Historic and Architectural Review
9	Commission Meeting were approved as submitted.
10	Other Old Business #1: None.
11	<u>New Business #1 – George Wallace, Jr./Garage Demolition:</u>
