In 2023, the Town of Denton, Regular Session Town Council Meetings will begin at 6:00 pm. We are moving the meetings ahead one hour from the old 7:00 pm start time.

Most of the working sessions will also start at 6:00 pm, instead of 6:30 pm.

The decision to move the time forward is an effort to make sure we start at a reasonable hour to allow those who work during the day to attend but also end at an effective time.

## Tax Sale Reminder

The 2022 - 2023 Real Property Tax Sale process will begin soon. If you have not paid your real property taxes, water and sewer billings or any other miscellaneous service charges to the Town of Denton, please do so immediately to avoid losing your property during the Tax Sale process.

All real property taxes were due in full by December 31, 2022 and are to be paid at the Caroline County Tax Office, located in the Caroline County Court House. To verify that your real property taxes have been paid, please call the County Tax office at 410-479-0410. If you want to check to see if you have any other outstanding bills due on your property within the Town of Denton, please contact the Finance Dept. at 410-479-2050.

## UTILITY BILL ALERT!

Utility bills will be mailed around January 1, 2023. To avoid having your water turned off **payment must be received by January 25, 2023.** Payments can be made in person Monday - Friday from 8:30 AM to 4:00 PM, online, by mail, at our drive-thru window, or by placing it in the night drop box located to the left of the front door.

Acceptable payment methods include cash, check, money order or cashier check. You can also pay by credit card at the office or online. The next utility bill will be mailed around April 1, 2023 and will be due in full by April 25, 2023.

Thank you to all of the volunteers who made a fun outing for kids to shop for their families.



# Helpful Winter Weather Tips

Here are some helpful tips to keep you and your home comfortable during this winter season.

To keep your pipes from freezing, turn off all outside spigots and insulate the pipes to protect them from the freezing temperatures.

To prevent water damage in your home, so you don't experience a burst pipe, locate all the water shut off valves. Don't wait for someone else to turn it off. The delay could cause major water damage.

As far as snow removal in the town, streets will not be plowed unless there is a 2 inch accumulation. The snow removal equipment cannot withstand clearing the street for a trace of snow.

When shoveling out your driveway pile the snow in your yard not in the streets and always pile it to the left side of your driveway. This prevents the snow from being pushed back in your driveway from the street.

During snow storms park as many cars as you can in the driveway to make snow removal easier. It may also prevent your vehicle from being damaged by other vehicles on the roads.

**EMERGENCY ROUTES** are a priority when removing snow, secondary roads and alleys are last. You must be patient the crews will get to your area as soon as possible.

Lastly, your safety and the safety of our snow removal crews are our number one concern. Let's do all we can to keep everyone out of harm's way.

#### SNOW PLOW POLICY

Planning for a winter storm event can be difficult. The variations in rate of snowfall, moisture content, air/surface temperatures, time of day, and wind velocity make each storm unique.

The purpose of this policy is to clarify and describe the Town's snow plowing and sanding priorities and the level of service that is intended to be provided by Town forces. The Town does not guarantee that streets will be free of snow and ice after plowing and/or sanding. Bare, dry pavement should not be expected. The Town will attempt to maintain adequate traction for vehicles properly equipped for winter driving conditions.

It is the goal of this effort to establish general policies and procedures that help make travel within the Town as safe as possible and to minimize economic hardship.

## Winter Coverlet Display



The Fiber Arts Center of the Eastern Shore invites you to see the amazing coverlet collection of Catherine K. Spence. Dates: January 4, 2023 through February 25, 2023.

Dated coverlets in the collection range from the late 1830's to 1850's.

Coverlets are woven bedcovers used as the topmost covering on a bed. The weaver worked on a loom to construct the textile itself one row at a time, and the pattern was woven in as part of the process. You will see beautiful overshot coverlets that were fashioned on weaving looms and are geometric in design incorporating a wide variety of stripe, square, diamond, medallion and other patterns.

You will also see double weave geometric, summer winter, and star work coverlets: and Jacquard coverlets. Come visit this beautiful textile display and be mesmerized by their beauty! The exhibit is free.

The Fiber Arts Center is open Wednesday through Saturday 12:00-4:00 and is located at 7N 4th Street Denton, MD.

Ordinance #736 - An Ordinance of the Town of Denton amending sections 5-1, 5-3, 5-7 and 5-12 of the Denton Town Code to change the start time of regular monthly meetings from 7:00 p.m. to 6:00 p.m.; change when agenda items must be submitted prior to the meeting; change the order of business; and to change the time limit for addressing the Council. Introduced 11/03/22, passed 12/05/22, effective 12/12/22.

Ordinance **#737**– An Ordinance of the Town of Denton to amend the Town of Denton's 2010 Comprehensive Plan, dated September 13, 2010, to modify the goals and objectives of the Mixed Industrial (MI) District. Introduced 12/05/22, to be considered on 01/05/23.

Ordinance #738- An Ordinance of the Town of Den-

ton to amend the Official Table

of Use Regulations, Appendix VII, in the Denton Town Code Zoning Ordinance and the provisions contained in Chapter 128 of the Denton Town Code with respect to microbrewery, micro distillery, micro winery, coffee roasting, and restaurant use in the Mixed Industrial (MI) District. Introduced 12/05/22, to be considered on 01/05/23.

**Ordinance #739** – An Ordinance of the Town of Denton revising and amending Chapter 14 of the Denton Town Code Pertaining to Ethics. Introduced 12/05/22, to be considered on 01/05/23.

### Service Fees for Utility Calls

All calls for utility service for properties located in the Town of Denton are assessed the following service fee. This fee applies for all water shut off/turned on, and other miscellaneous calls for service. Paying utility bills on time can help the property owner avoid these fees.

**Special Attention**: Any water that is turned off will be assessed this fee to have the water turned back on. Tenants will need to pay this fee before water service is turned back on. (This may not apply for emergency situations pending the nature of the call.)

### **Attention Settlement Attorneys**

Reminder to all settlement attorney's and agencies to please contact the Denton Town Office for fees due to the Town when handling settlements for properties being sold or transferred with in the Town limits. There may be water/sewer fees or miscellaneous charges that need to be collected at the time of settlement. This will keep the Town's records up to date and better serve the resident's of the Town of Denton. This will also eliminate problems after settlement of any outstanding balances for the new property owner.

**Please note:** Any property that transfers ownership and the utility fees are not collected at settlement and forwarded to the town that result in the water being turned off for non-payment, the water turn on fee will still be charged. This charged maybe passed on to the settlement attorney. Currently the fee to turn water service back on during regular business hours is \$50.00 and after 3:30 PM the fee is \$100.00.
