

Speed Radar Cameras in School Zones

In the interest of Public Safety the Town of Denton will be joining other jurisdictions in the State of Maryland to utilize speed radar cameras. It is expected that the first camera will be in place at the beginning of June.

The program will start with a 30-day period in which only warnings will be issued. After the trial period, citations will be issued to owners of vehicles that are photographed going at least 12 miles per hour over the posted speed limit. Fines for violations will be \$40, but no points will be assigned to a driving record for convictions.

Citations can be contested in Maryland District Court. The cameras will be used in school zones where the speed limit is 25 miles per hour or less.

The Town of Denton will be publicizing the location of its cameras in a number of ways, including in news releases, Town publications, on the Town websites and social media.

The Town of Denton Police Department is considering several possible stretches of roadways where cameras may be most effective. The actual locations will be determined using data from speed surveys.

Chief Rodney Cox states, "Our primary goal is the increased safety of our citizens, including our student population, traveling in and around our school areas."



Legion Road Closure at Rounte 404

Beginning April 30, 2012, Legion Road from the new Walmart entrance to the west, just after the Denton Plaza entrance, to before Denton Public Works (DPW) entrance to the southeast will remain closed for construction activity related to the Walmart Project, pending final inspection and approval of the detour sign installation by the Town of Denton (TOD) on Town-owned roads, State Highway Administration (SHA) on Route 404, and bond posting for the MOT. Full Legion Road closure is effective from April 30 to July 30, 2012, and reopen on July 31, 2012.

The entrances off Legion Road to Denton Plaza and Subway are to remain open and accessible. Intermittent lane closures may take place after July 31, 2012, until the project completion. Please stay alert, slow down, and take additional precautions as you drive in this area during this time.

Acceptable payment methods include cash, check, money order or cashier check. The next Utility bills will be mailed around October 1, 2012 and will be due in full by October 25, 2012.

Water Bills to be mailed July 1, 2012 PAY WATER BILLS ON TIME TO AVOID SERVICE DISCONNECTION & EXTRA FEES

Utility Bills will be mailed around July 1, 2012 and are due to be paid by July 25, 2012. Interest at the rate of 1% is added on July 25, 2012.

Past due notices (red cards) will be mailed on July 25, 2012 for any account that has an overdue balance; this is the FINAL REMINDER prior to having the water service shut off.

Payments can be made during **summer office hours**, **Monday through Thursday**, **7:30a.m. to 5:00p.m.**, or after hours by placing the payment in an envelope in the night deposit box located to the right of the front door on the outside of the Town Office building.

Water turned off for non-payment will be assessed a service charge in order to have the water turned back on. The water turn-on service charge is \$50.00 if turned back on before 3:30p.m., and \$100.00 for after hours, this fee is subject to change.

It is the property owner's responsibility to ensure that payments are made in a timely manner.

Landlords and property managers who have arrangements for the tenants to pay the bills, please be sure to forward the bills to the tenants immediately upon receiving them to ensure prompt payment and to avoid shut off issues. In the past several tenants have stated that they do not receive the bill until the day it is due or when late notices have been sent.

Failure to receive the bill does not relieve the responsibility of the payment that is due. If a citizen is unable to make their payment by the due date, please contact the Finance Department at 410-479-2050 prior to July 25, 2012.

Water service will be shut off for non-payment.

Caroline County "Drop it in the Box" Prescription/Medication/Drug Drop Box Program

Beginning ???, the new **Drop it in the Box** program is offering a way to safely dispose of unused prescription and over-the-counter medications. The program is offered through a partnership between the Denton Police Department and the Drug Free Caroline Coalition; funded by the Tri-County Prevention Project and Maryland Alcohol and Drug Abuse Administration. It is the FIRST medication drop-off program of its kind in Caroline County.

Caroline County residents can drop off unused medications -- including prescription, over-the-counter, and pet medications, as well as liquid medications in leak-proof containers, and illegal drugs and drug paraphernalia (such as pipes and other objects) -- in the *Drop it in the Box* drop box located at the **Denton Police Department, 100 North 3rd Street, Denton, Monday through Friday, 9:00a to 5:00p**. The box is located in the lobby of the Police Department

PLEASE: Prepare your medication for disposal by leaving the medication in the original container, removing your name and personal information. Keep the name of the medication visible on the container, and then bring the medication to Denton Police Department and drop medication into the disposal box. *All drop-offs are anonymous.* The drop box locations have padded envelopes available for placing liquid and breakable bottles in to for disposal.

If disposing of illegal drugs and/or drug paraphernalia (such as pipes and other objects items), please put them in a paper bag or other container for privacy before dropping them into the disposal box. The opening of the drop box is about three by 10 inches; it is designed so that once something is dropped into the box, it can only be taken out by a law enforcement officer and is emptied daily. Medicines will then be taken to a licensed site to be incinerated at extremely high temperatures.

Prior to this program, people commonly disposed of leftover medications by throwing them in the trash or flushing them down a sink or toilet. However, rising concerns over the illegal use of prescription medications; as well as the environmental impact of these practices, prompted officials to ask individuals to refrain from these disposal methods or from just keeping them in the medicine cabinets and forgetting about them. The *Drop it in the Box* program promotes the safe use, safe storage and, in particular, safe disposal of unneeded medication. The Caroline County community is serious about preventing medication misuse/abuse as well as environmentally safe disposal of unneeded medication.

If you know someone who has a large amount of unneeded medication but is unable to bring it in for disposal, friends or family members may bring medication to *The Box* for someone else. **Please note:** sharps/needles and infectious waste cannot be accepted.

Thunder Storms and Lightning

Thunderstorms often come up suddenly and can present a variety of hazards, including power outages caused by lightning, heavy rains, hail, and wind. Such storms usually affect Maryland in the late spring, summer, or early fall, but can happen any time cold and warm air masses collide. Thunderstorms are sometimes even associated with

snow showers. About 2,000 thunderstorms are in progress around the world at any given moment with lightning striking about 100 times every second. And yes, lightning can, and does, strike twice! Each year lightning kills 80-100 people and injures hundreds more.

Thunderstorms and lightning are very common for Maryland. Here's what you can do to protect yourself:

• Before a storm be aware of weather forecasts at all times.

• Watch for signs of approaching storms.

• Keep a battery operated radio handy.

• Postpone outdoor activities if thunderstorms are likely

• Remember, if you can hear thunder, you are close enough to the storm to get struck by lightning. Get to shelter immediately.

• Get out of boats and away from water.

• Unplug appliances, avoid using the telephone.

• Do not bathe or shower.

• Get to higher ground if flash flooding is likely to occur from the storm.

> • If out doors and shelter is not nearby, find a low spot away from trees, fences and poles.

If you feel your skin tingle or your hair stand on end, you are about to be struck by lighting! Squat low to the ground on the balls of your feet.

Place your hands on your knees with your head between them. Make yourself the smallest target possible, and minimize your contact with the ground.



Denton Public Works . . . Be Prepared During An Emergency

June is the beginning of hurricane season. Hurricanes are tropical cyclones that can cause extensive damage due to high winds and flooding. Residents in areas along the Atlantic coastline and the Gulf of Mexico are urged to prepare themselves and their families for the possibility of tropical storms and hurricanes. These storms bring immense rainfall, very strong winds, major inconveniences, and the possibility of damages and flooding.

June is the beginning of opener or buy food in self- opening icane season. Hurricanes are cans;

• Pack foods in sealed metal or plastic containers and replace every six months;

• Radio, battery powered or hand crank, and extra batteries;

• First aid kit and whistle to signal for help;

• Plastic sheeting and duct tape to shelter in place;

• Prescription medications and glasses;

• Sleeping bags or blankets



Having a plan is one of the most important steps you can take in disaster preparedness. Knowing what to do and how to do it can help your family manage disasters with less worry, fear, and uncertainty. Plans should include a communications plan, a pet plan, address sheltering-in-place, going to emergencyshelters, and evacuations. It is important to discuss how these storms could affect your family, know your home's vulnerability to flooding, rain, and wind, and make sure every family member knows what to do and where to go. Arrange for a contact outside the area for everyone to call if your family becomes separated.

Prepare an emergency supply kit that will allow you and your family to survive for several days. The kit should contain:

• At least 1 gallon of water per person per day for at least 3 days;

• Canned and boxed foods that require little preparation and stay good for long periods of time. Remember to bring a manual can

e for each person;

• Moist towellettes, garbage bags and plastic ties

• Family documents, copies of insurance policies, identification and bank account records in a water proof container; change of clothing including a long-sleeved shirt, long pants, and sturdy shoes; and

• Matches in a waterproof container.

Preparations for the home should include removing all items from outside which may blow and hit houses or cars. Keep your vehicle's fuel tank at least half full. During a hurricane, take refuge on the ground floor in a small central room or hallway. Stay away from windows and glass doors. Stay indoors—do not drive.

Knowing what to do during an emergency is important. Being prepared means staying informed prior to, during, and after a tropical storm or hurricane. The local emergency management office will provide information on the location of shelters and evacuation orders.

New Trash Collection Company

Chesapeake Waste Industries from Salisbury, Maryland, will begin providing weekly trash collection services to the Town of Denton beginning Tuesday, July 3, 2012.

Containers must be placed at curb/alley or roadside by 6:00a.m. on collection day, but shall not be placed out prior to 5:00p.m. on the day before collection and must be

removed by 11:00p.m. on collection day.

There is a limit of 4 thirtytwo (32) gallon metal or plastic containers that are water tight, have handles, and tight fitting lids per residential unit. Waste wheelers are limited to 128 gallon capacity.

That the rate of taxation on real property to be taxed within the boundaries of the Town of Denton, Maryland shall be and hereby is established as:

Sixty-eight cents (\$.68)

on each one hundred dollars (\$100.00) of the value for the fiscal year beginning July 1, 2012 and including June 30, 2013.

Sec. 3 Rate of Taxation on Business Personal Property

That the rate of taxation for the fiscal year beginning July 1, 2012 and including June 30, 2013, on any incorporated personal property to be taxed by the Town of Denton, Maryland, shall be and hereby is established as:

One Dollar and Fifty cents (\$1.50)

on each one hundred dollars (\$100.00) of assessed valuation, unless otherwise provided for by Article 81 of the Annotated Code of Maryland.

Sec. 4 Rate of Taxation on Railroad and Utility Property

That the rate of taxation for the fiscal year beginning July 1, 2012 and including June 30, 2013 on any railroad and utility property to be taxed by the Town of Denton, Maryland, shall be and hereby is established as:

One Dollar and Seventy cents (\$1.70)

on each one hundred dollars (\$100.00) of assessed valuation, unless otherwise provided for by Article 81 of the Annotated Code of Maryland.

Sec. 5 Service and Administration Fee Collected by Caroline County Tax Office

That the rate of service and administrative fees on semi-annual billings assessed by the Caroline County Tax Office shall be and hereby is established as:

.29% Service Fee and a 10% Administrative Fee for 2012-2013. The fee and charge amount to .32%. This is computed at 1.15% annual interest divided by twelve months times three months, October, November & December.

historic downtown Denton. This event will kick off on Thursday, August 2, 2012, and will end on Sunday, August 5, 2012, with ribbon-cutting festivities at the new fiber arts center.

Inspiring as a speaker, Elly Sienkiewicz has lectured for museums, including the Smithsonian Institution and the Abby Aldrich Rockefeller Museum, where her work as a quilt historian has been recognized. She has taught classes around the United States, and on five continents. A Silver Star honoree for her "profound contribution to the contemporary Quilting Revival" of the past half-century, Sienkiewicz's work has been in quilt magazines in the US, Europe, and Japan. Recently, Quilters Newsletter readers voted her "America's Best Quilting Teacher" while her Appliqué 12 Easy Ways! won the Quilt Industry Classics Award for Best Book on appliqué. For twenty books, and counting, she has been designing, stitching, teaching, and writing about appliqué – from the

basics to Baltimore Albums.

Elly Sienkiewicz will be teaching her Star Ruching class on Thursday August 2; and her Quick-Start Baltimore & Portrait of the Artist class on Friday, August 3. On Saturday, August 4, Sienkiewicz will be giving a lecture on Baltimore Albums: A Visible Face of Social Revolution. Through glorious photos, view the momentous age that made America what she has become. Across today's industrialized world from Tokyo to Capetown to Calgary, great numbers have enjoyed Baltimore's Revivalist journey for 30 years now. Attention Settlement Attorneys

Reminder to all settlement attorneys and agencies to please contact the Denton Town Office for fees due to the Town when handling settlements for properties being sold or transferred within the Town limits. There may be water/sewer fees or miscellaneous charges that need to be collected at the time of settlement. This will keep the Town's records up to date and better serve the residents of the Town of Denton. This will also eliminate problems after settlement of any outstanding balances for the new property owner.

Please note: Any property that transfers ownership and the utility fees are not collected at settlement and forwarded to the town that result in the water being turned off for non-payment, the water turn on fee will still be charged. This charged may be passed on to the settlement attorney. Currently the fee to turn water service back on during regular business hours is \$50.00 and after 3:30p.m., the fee is \$100.00. Forms are available to use when requesting information. Any questions, please call the Town of Denton at (410) 479-2050.

Service Fees for Utility Calls

All calls for utility service for properties located in the Town of Denton are assessed the following service fee. This fee applies for all water shut off/turn ons, and other miscellaneous calls for service. Paying utility bills on time can help the property owner avoid these fees.

Special Attention: Any water that is turned off will be assessed this fee to have the water turned back on. Tenants will need to pay this fee before water service is turned back on. (This may not apply for emergency situations pending the nature of the call.)
