SNOW PLOW POLICY INFORMATION

Planning for a winter storm event can be difficult. The variations in rate of snowfall, moisture content, air/surface temperatures, time of day, and wind velocity make each storm unique.

The purpose of this policy is to clarify and describe the Town's snow plowing and sanding priorities and the level of service that is intended to be provided by Town forces. The Town does not guarantee that streets will be free of snow and ice after plowing and/or sanding. Bare, dry pavement should not be expected. The Town will attempt to maintain adequate traction for vehicles properly equipped for winter driving conditions.

It is the goal of this effort to establish general policies and procedures that help make travel within the Town as safe as possible and to minimize economic hardship.

It's Boat Ramp Permit Season

Boating season is here. Just a reminder, effective April 1, 2009, a permit is required to launch any vessel, via boat trailer, at all Caroline County boat ramps and public

landings.

Permits m a y b e purchased for one day use or annual use and vary in price.

A one day pass for Maryland residents is \$5 and \$10 for out of state residents. Annual pass fees are \$20 for Maryland residents and \$50 for out of state residents. Annual permits are valid

only when displayed on the driver's side of the boat trailer tongue, within 12 inches of the hitch. Daily permits must be hung on the inside mirror facing the windshield. Fines for

a first offense are \$50, and a second offense is \$100.



Swimming Pool Permits

The Town of Denton requires property owners to obtain permits for all swimming pools above 24 inches deep. Accessory swimming pools may occupy a rear or side yard

provided they are not located closer than 6 feet to a rear lot line or 10 feet to a side lot line. Pools are required to be protected by a safety fence or

equipped with a self latching Codes, 4 N. Second.

closure mechanism. A walk space of at least 3 feet wide shall be provided between pool walls and fences. Where an aboveground pool structure is used as the protective

GRASS CUTTING SEASON REMINDER

Please remember to keep your lawn trimmed to 6 inches or shorter.

Public Works...

6th Street Sewer Clog



On February 6th Denton Public Works were called to 6th Street responding to a clog in the swerer lines. After hours of work and detoured traffic, the problem was located and removed. It was a number of "flushable wipes" (pictured above) that were caught in the sewer lines that caused the problem.

Although companies sell some wipes as "flushable" our staff at

the Public Works Department can tell you these products frequently cause problems for Denton's sewer system.

If you use these products, please **reconsider** flushing them. They do not break down quick enough and often times cause major issue in clogged pipes and damaged machinery at the plant.

Please refer to the additional information below. Thank you for helping us keep the pipes clear.

Winter Weather Tips

Here are some helpful tips to keep you and your home comfortable during this winter season.

To keep your pipes from freezing, turn off all outside spigots and insulate the pipes to protect them from the freezing temperatures.

To prevent water damage in your home, so you don't experience a burst pipe, locate all the water shut off valves. Don't wait for someone else to turn it off. The delay could cause major water damage.

As far as snow removal in the town, streets will not be plowed unless there is a 2 inch accumulation. The snow removal equipment cannot withstand clearing the street for a trace of snow.

When shoveling out your driveway pile the snow in your yard not in the streets and always pile it to the left side of your driveway. This prevents the snow from being pushed back in your driveway from the street.

During snow storms park as many cars as you can in the driveway to make snow removal easier. It may also prevent your vehicle from being damaged by other vehicles on the roads.

EMERGENCY ROUTES are a priority when removing snow, secondary roads and alleys are last. You must be patient the crews will get to your area as soon as possible.

Lastly, your safety and the safety of our snow removal crews are our number one concern. Let's do all we can to keep everyone out of harm's way.



Spring Loose Leaf Collection

The Town of Denton will be providing a special spring loose leaf collection service to vacuum up leaves that are left over from the fall. The Denton Public Works Department is scheduling their loose-leaf removal service to occur on Friday April 3, Monday April 6, Monday April 13, Friday April 17, Monday April 20 and Friday April 24, 2020. Leaves must be bagged for pickup the remaining months of the year.

Leaf vacuuming will occur on Friday and/or Monday pending workload. It will be necessary to call in your loose-leaf vacuum pickup request by 12 NOON on Thursday to guarantee pickup by Monday. We asked that you please only have one pile of leaves and have it located at the edge of your property, without obstructing sidewalks or roadways, where it can easily be accessed by Public Works.

Bagged leaf collection will still take place on Wednesdays and must be called in to the town office by 12 NOON on Tuesdays.

Citizens are encouraged to call the Town Office at 410-479-2050 to request pickup. If calling after hours please leave the requests

on the Town Office answering machine, ext. 1.

Please follow these guidelines for leaf removal:

- Rake leaves to the curbside or alley
- DO NOT rake leaves into the street
- DO NOT rake leaves onto the sidewalk
- Make sure all sticks and limbs are removed from the pile of leaves
- Make sure there are no other objects or debris mixed with the leaves (like bottles, cans, flowerpots, gloves, ashes, pet waste or other trash)
- Piles of leaves with sticks, limbs or other debris will not be picked up
- Phone in your pickup request to the Town Office at 410-479-2050 by Thursday to guarantee pickup by Monday
- All pickups will be done by request/appointment only
- Loose leaf pickups will occur from April 3 through April 24, on Mondays and Fridays only. Leaves must be bagged any other time.

IMPORTANT NOTICE - Wipes & Personal Hygiene Products Clog Sewer Lines!

Many household products are labeled and marketed as DISPOSABLE and/or FLUSHABLE; many baby and adult personal hygiene products, along with household wipes and cleaning towelletes are tabeled both disposable and flushable. While these products may be marketed as a convenience item in this way, the tith is that these bross of items have the ability to cloq and stop up not only the sewer line on your property, but also can cause blockage and service problems in the public sewer system and pump stations.

Unlike toilet paper, these products <u>DO NOT</u> break down once they are flushed. They can cause blockages in your on-site sower, especially older pipelines that may have greases, roots, or other obstructions already existing. A repair of the on-site sewer line can leave the home owner or business owner with a very costly sewer repair.

On a larger scale, when these products make their way into the public sewer system they collect together, causing very large obstructions and clogs in the main collector lines and get tangled in pump stations requiring repair or replacement of equipment.

What We All Can Do To Help...

The following items should <u>MEVER</u> be flushed into the sewer system:



Every home and business has a sewer connection to the public sewer system. This connection runs from the home or business to the sewer main where it is connected to the public sewer system. This on-site sewer line is the responsibility of the home or business owner to keep clear so there are no back-ups of wastewater into the home or business. Save yourself and your Sewer Utility from costly repairs and/or replacement bills. Do not flush the listed items; place them in the trash, not the toilet.

We're making sure that **however you choose to respond**—online, by phone, or by mail—that **the census is accessible**. You'll receive an invitation to respond **beginning in mid-March**. You choose how you want to respond.



You can respond **online** in English or in 12 additional languages. The online questionnaire is accessible, following the latest web accessibility guidelines. We'll also have a video in **American Sign Language** available to guide you through responding online.



You can respond by **phone** in English or in 12 additional languages. You can also respond in English by **TDD** at 644-467-2020.



By mid April, we'll mail a **paper questionnaire** to every household that hasn't already responded (Some households will receive a paper questionneire along with the first invitation in Merch.)

We'll have **braille and large print guides** available online to assist you with completing the paper duest onnaire.



If necessary, you can respond **in person** beginning in mid-May. Census takers will visit all households that have not yet responded.

We'll have census takens available who can communicate in **American Sign Language** and additional languages. When the census taker visits to help you respond, you can request that another census taken who communicates in American Sign Language returns, if you prefer.

If you prefer, you may also choose to have another member of your household interact with the densus taker.

Responding is important. A complete count helps ensure that services like Medicare Modicard social security, and cuidic transportation can suspen those who need them:

THE 2020 CENSUS IS COMING, HERE'S WHAT YOU SHOULD KNOW



The census is intended to count every living person (citizens and non-citizens) in the United States.

Census data determines how federal dollars are distributed

for programs such as SNAP, CHIP, Headstart and the National School Lunch Program. It also helps businesses choose where to invest in new factories, offices and other job opportunities.



For the first time ever, we'll be allowed to complete the census form online.

This move is intended to increase opportunities to engage hard-to-count populations. (But don't worry, there will still be an option to complete your form by mail or even by phone!)

In March 2020, the census will be open for all U.S. residents to take.

Each household will receive a notification in the mail that lists the 2020 Census website and a unique User ID in order to fill out the survey online. The Census Bureau will begin following up with people who haven't filled out the questionnaire in May.

Attention Settlement Attorneys

Reminder to all settlement attorneys and agencies to please contact the Denton Town Office for fees due to the Town when handling settlements for properties being sold or transferred within the Town limits. There may be water/sewer fees or miscellaneous charges that need to be collected at the time of settlement. This will keep the Town's records up to date and better serve the residents of the Town of Denton. This will also eliminate problems after settlement of any outstanding balances for the new property owner.

Please note: Any property that transfers ownership and the utility fees are not collected at settlement and forwarded to the town that result in the water being turned off for non-payment, the water turn on fee will still be charged. This charged may be passed on to the settlement attorney. Currently the fee to turn water service back on during regular business hours is \$50.00 and after 3:30p.m., the fee is \$100.00. Forms are available to use when requesting information. Any questions, please call the Town of Denton at (410) 479-2050.

Service Fees for Utility Calls

All calls for utility service for properties located in the Town of Denton are assessed the following service fee. This fee applies for all water shut off/turn ons, and other miscellaneous calls for service. Paying utility bills on time can help the property owner avoid these fees.

Special Attention: Any water that is turned off will be assessed this fee to have the water turned back on. Tenants will need to pay this fee before water service is turned back on. (This may not apply for emergency situations pending the nature of the call.)

The 2019 - 2020 Real Property Tax Sale process will begin soon. If you have not paid your real property taxes, water and sewer billings or any other miscellaneous service charges to the Town of Denton, please do so immediately to avoid losing your property during the Tax Sale process.

All real property taxes are due in full by December 31, 2019 and are to be paid at the Caroline County Tax Office, located in the Caroline County Court House. To verify that your real property taxes have been paid, please call the County Tax office at 410-479-0410. If you want to check to see if you have any other outstanding bills due on your property within the Town of Denton, please contact the Finance Dept. at 410-479-2050.
