Historic Caroline High School Awarded Smart Site Designation

Fall Loose Leaf Collection

Autumn is approaching and soon the leaves will begin to fall. The Denton Public Works Department is scheduling their annual loose leaf vacuuming removal service to occur October 18 through December 13, 2010. Leaves must be bagged for pickup the remaining months of the year.

Loose leaf vacuuming will occur on Friday and/or Monday, pending work load, and excluding holidays. It will be necessary to call in your loose leaf vacuum pickup request by 12

NOON on Thursday to guarantee pickup by Monday.

Bagged leaf collection will still take place on Wednesday and must be called in to the Town Office by 12 NOON on Tuesday.

Citizens are encouraged to call the Town Office at 410-479-2050 to request pickup. If calling after hours please leave the request on the Town Office answering machine, ext. 25.

Please follow these guidelines for leaf removal:

- * Rake leaves to the curbside or alley.
- * DO NOT rake leaves into the street.
- * DO NOT rake leaves onto the sidewalk.
 - * Make sure all sticks and limbs are removed from the pile of leaves.
 - * Make sure there are no other objects or debris mixed with the leaves (like bottles or other trash).
 - * Piles of leaves with sticks, limbs, or other debris will not

be picked up.

- * Phone in your pickup request to the Town Office at 410-479-2050 by Thursday to guarantee pickup by Monday.
- * All pickups will be done by request/appointment only.
- * Loose leaf pickups will occur from Oct. 18 through Dec. 13, on Mondays and Fridays only, except for holidays.

Loose leaf collection days:

- -November 1, 5, 8, 12, 15, 19, 22, 26, 29.
- -December 3, 6, 10, 13.

Bay Country Chorus is an allmale barbershop chorus founded in 1995, and has a proud tradition of performance and service to the community. Barbershop style is four- part, a cappella, close-

harmony singing with the melody sung in the second voice called the "lead." The tenor harmonizes above the lead; the bass sings the lowest harmonizing notes and the baritone provides the in-between notes to form consonant, pleasing chords.

The music is in the style of "old songs" from the heyday of Tin Pan Alley.

Denton 2010 Code Updates

Chapters 128 & 73

The Town of Denton has approved updates to Chapters 128 "Zoning" and 73 "Land Subdivision." A public hearing was conducted at the beginning of the Town Council meeting held on September 13, 2010. The Town Council approved the revisions to both chapters on September 13, 2010 by adopting Ordinances No. 611 and 612. The Town of Denton is authorized by Maryland Annotated Code Article 66B §§4.04 and 4.05 to amend, supplement, modify or repeal sections of the zoning ordinance.

Changes to both chapters reflect consistency with the Town's Comprehensive Plan revision which was adopted on July 12, 2010, and subsequently amended on September 13, 2010, to reflect a zoning change to one property. Code changes include comments from the Town Engineer, Kercher Engineering, DPW Director Scott Getchell, Denton Town Council and the Denton Planning Commission. The final draft was reviewed by the Town Attorney.

The most notable changes to Chapter 73 – Subdivision are: expanded and updated definitions, increased timeframe period between submittal and hearing, proof taxes are paid in full and reference to requirement for developer to pay into an escrow account and replenish when triggered, prohibit cul-de-sac streets (unless approved by Planning Commission), a total prohibition of T-type or L-type cul-de-sacs,

requirement for traffic impact studies, prohibition of stormwater retention or detention basins in open space areas, prohibition of propane gas farms in open space area, more specificity of concept, preliminary and final plat submissions, plus more specificity on inspections, warranties and bonding/letters of credit.

Chapter 128 – Zoning had many changes that were prepared to reflect consistency with the 2010 Comprehensive Plan. The most notable of these changes are: expansion of the definition section, additions to the zoning districts' descriptions to include new zoning districts such as the Mixed Industrial, Recreation & Parks, and Rural Agriculture zones, the use of "net site area" (gross area minus lands with environmental and other easement constraints) to determine density, expansion of the supplementary use descriptions, increased requirements manufactured home and subdivisions, inclusion of Outdoor Lighting chapter, revision to the "Sign" article with an illustration appendix, revisions to the "Table of Use" regulations that include permitted uses for new districts and removed two family conversion from single family, requirements for Public Notice was revised to require certified letter sent to all property owners within 200 feet of a subdivision or major site plan, with cost of mailing paid and sent by applicant.

Denton Public Works . . .

5th Avenue Under Construction

The Fifth Avenue Roadway and Utility Reconstruction Project is underway. This project begins at the intersection of Fifth Avenue and Market Street and extends southerly along Fifth Avenue for a total distance of 0.89 miles, to include two blocks of Randolph Street, two blocks of Fountain Avenue, onehalf block of Edenton Avenue, and portions of Kerr Avenue, and Carter Avenue. The scope of the overall project includes the replacement of old and undersized water mains and services, improvements to stormwater drainage inlets, the replacement and/or installation of new curb/ gutter, will provide ADA compliant handicap ramps, crosswalks, driveway entrances, signage, new roadway pavements and striping, and landscaping.

This project is being administered by the Town of Denton Public Works Department and is being funded both by the American Recovery and Reinvestment Act of 2009 through the Maryland State Highway Administration and the U.S. Department of Agriculture-Rural Utility Service. The project is funded through a combination of grants and loans available through the two funding sources. anticipated completion date is spring of 2011.

Winter Energy Saving Tips

With energy prices rising across the country, now is a good time to learn how to use energy wisely. Here are some simple tips to help you reduce your energy consumption:

During the winter months, set your thermostat at 68 degrees during the day and 60 degrees at night. You can save 3 percent on your heating costs for every degree you reduce the temperature below 70 degrees.

Special Advice to Heat Pump Owners: Heat pumps need to stay at a constant setting, unless you have a programmable electronic heat pump thermostat with adaptive recovery. Check with your heating or air conditioning contractor to determine the type of thermostat you have.

Winterize windows with weather stripping (for all moveable joints) and caulk (for non-moving parts). Also, install a window kit to the inside of your windows to help keep cold air out and warm air in.

Change filters once a month. A well-maintained heating system can save money and increase the comfort level in your home.

When you cozy up to a crackling fire on a cold winter day, you may be losing more heat than you are generating if your fireplace is not airtight.

Inspect ductwork for any air leakage. If you do feel air leaking at joints, use silver metal duct tape to seal them. You could save up to 10% of your heating costs by eliminating those leaks.

Prepare Your House for Winter

The Public Works Department experiences many calls from residents during the winter months to turn off water after pipes have frozen and broken. In the time that it takes for us to respond much damage could have taken place. It is better to be pro-active in taking a

few simple precautions and save yourself the mess, money, and aggravation frozen pipes cause.

What's the solution? Besides moving to Florida, installing a water shutoff valve inside your home

is recommended. In the event of an emergency, a shutoff valve will provide the means to immediately shut off the water, preventing a catastrophe if you are not at home.

A local plumber can perform this installation. Once installed it is important to make sure that everyone in your household is aware of the location of the valve. The valve should be operated periodically to prevent it from seizing up. If your home is already equipped with a shutoff valve, verify its location and ensure that it works.

In addition to having a valve installed, pipes exposed to cold air should be properly insulated to further prevent problems. When

> temperatures drop below freezing, the pipes in the exterior walls and under your house could be affected. When water freezes inside a pipe, it expands and inevitably ruptures the pipe. Water damage can and will

occur in a short amount of time.

Wrap insulation around water pipes that are close to the ground or in unheated spaces such as the attic. Disconnect garden hoses from all outdoor faucets. Turn off outside water lines, and then open the outside spigots to drain any water still in the pipes. This reduces the chance of freezing in the short span of pipe just inside the house.

Plants Can Improve Indoor Air Quality

In the late 1980s, a two-year research study was conducted by



NASA and the Associated Landscape Contractors of America to investigate ways to create healthy, breathable

environments in outer space. The tests were conducted in sealed test chambers containing pollutants such as formaldehyde, benzene, and trichloroethylene, all commonly present in indoor air from paints, varnishes, insulation, particleboard, pressed wood, adhesives, inks, rubber, and other sources. Scientists found that certain tropical plants commonly used as houseplants were quite effective in removing these chemicals from the indoor air.

Forests are important maintaining the delicate balance of the earth's atmosphere because they "breathe" in carbon dioxide and

release oxygen into the air. Certain houseplants can also remove and process other, more harmful, chemicals from the air inside your home or office. Modern buildings are tightly sealed and insulated to make them energy efficient, and they are also full of synthetic materials that emit harmful gases and chemicals into the air. The result is a sealed bubble of unclean air that can lead to what is known as "Sick Building Syndrome".

All plants provide some benefit to air quality, but research showed that tropical plants were particularly effective at processing gases and chemicals. Because these plants grow in dense rainforests with low light conditions, they have evolved to be very efficient at capturing light as well as in processing the gases necessary for photosynthesis. Plants take in carbon dioxide and expel oxygen. Human beings inhale oxygen and expel carbon dioxide. Thus houseplants can lower the levels of carbon dioxide and increase the levels of oxygen in the home or office.

The study vielded a list of common houseplants found at your local garden centers that reduce the level of toxic chemicals in indoor environments. For best results, have at least one six-inch plant for every 100 square feet.

The list includes:

Bamboo Palm (Chamaedorea seifrizii)

Chinese Evergreen (Aglaonema modestum)

Dracena "Janet Craig" (Dracaena deremensis "Janet Craig")

English Ivy (Hedera helix)

Ficus or Weeping Fig (Ficus benjamina)

Gerbera Daisy (Gerbera jamesonii)

Golden Pothos (Epipiremnum

Peace Lily (Spathiphyllum) Philodendron (Philodendron) Pot Mum (Chrysanthemum

morifolium)

Snake Plant or Mother-In-Law's tongue (Sansevieria trifasciata "Laurentii")

Spider Plant (Chlorophytum comosum)

Schefflera/Umbrella Tree (Brassaia actinophylla)

Airborne chemicals are not the only health hazards indoors. Scientists at Washington State University conducted a study that led them to conclude that foliage plants can reduce indoor dust levels by up to 20%. 



Conway Gregory, Mayor of Denton said "The Culinary School is another boon for the Town in terms of economic revitalization of the downtown. We now have an active school program training people for marketable skills in one of the fastest growing markets--the hospitality industry--and protecting an old school that will promote our history and tourism."

The Caroline High School (circa 1901), located at 512 Franklin Street in Denton, is a historically significant building located in Denton's National Register Historic District but has been vacant for the past 23 years. The building is one of the oldest public structures in Caroline County and the property one of the largest open spaces in the Denton. The Town of Denton,

in partnership with the Chesapeake Culinary Center and the Denton Development Corporation have been working on rehabilitating the structure to a statue of utility, while preserving features which are significant to historical, architectural, and cultural values of the Eastern Shore community.

Once renovation of Caroline High School is complete, the


building will serve as the Chesapeake Culinary Center's hospitality training headquarters, as well as provide a community incubator kitchen and small bottling facility. The kitchen incubator program will provide new business owners the resources necessary for success and existing businesses opportunity for growth. The business owner will be able to prepare a product at the Caroline High School facility, alleviating expenses associated with the purchase of equipment and space for production.

"The Caroline High School project demonstrates in Caroline County's community revitalization efforts and promotion of sustainable growth." said Abigail McNinch of the Denton Development Corporation. The Caroline High School project, similar to all Smart Sites throughout Maryland will:

Attention Settlement Attorneys

Reminder to all settlement attorneys and agencies to please contact the Denton Town Office for fees due to the Town when handling settlements for properties being sold or transferred within the Town limits. There may be water/sewer fees or miscellaneous charges that need to be collected at the time of settlement. This will keep the Town's records up to date and better serve the residents of the Town of Denton. This will also eliminate problems after settlement of any outstanding balances for the new property owner.

Please note: Any property that transfers ownership and the utility fees are not collected at settlement and forwarded to the town that result in the water being turned off for non-payment, the water turn on fee will still be charged. This charged may be passed on to the settlement attorney. Currently the fee to turn water service back on during regular business hours is \$50.00 and after 3:30 p.m., the fee is \$100.00. Forms are available to use when requesting information. Any questions, please call the Town of Denton at (410) 479-2050.

Service Fees for Utility Calls

All calls for utility service for properties located in the Town of Denton are assessed the following service fee. This fee applies for all water shut off/turn ons, and other miscellaneous calls for service. Paying utility bills on time can help the property owner avoid these fees.

Special Attention: Any water that is turned off will be assessed this fee to have the water turned back on. Tenants will need to pay this fee before water service is turned back on. (This may not apply for emergency situations pending the nature of the call.)

Ordinance #612 – An ordinance of the Town of Denton repealing and reenacting with amendments Chapter 73, Land Subdivision of the Town Code. Introduced 08/09/10, adopted 09/13/10, effective 09/20/10.

Ordinance #613 – An ordinance of the Town of Denton approving an historical facade easement on a building know as "Plain Dealing", located at 808 S. 5th Avenue in the Town of Denton. Introduced 08/09/10,

adopted 09/13/10, effective 09/20/10. Resolution #739 – A resolution of the Town of Denton adopting amendments to the Town of Denton 2010 Comprehensive Plan.. Adopted 09/13/10.
