## ORDINANCE NO. 719

INTRODUCED BY:	

AN ORDINANCE OF THE TOWN OF DENTON AMENDING THE OFFICIAL ZONING MAP OF THE TOWN OF DENTON TO APPLY THE GENERAL COMMERCIAL (GC) ZONING DISTRICT TO PARCELS OF LAND REZONED FROM TOWN SCALE RESIDENTIAL (TR) IN THE TOWN OF DENTON LOCATED ON CAROLINE COUNTY TAX MAP 103, GRID 12, PARCELS 998 AND 1000

WHEREAS, the Town of Denton ("Town") is authorized by the Maryland Annotated Code ("Code"), Land Use Article, Section 4-204 to amend the Official Zoning Map; and

WHEREAS, the Official Zoning Map of the Town of Denton has not been updated and republished since August 2, 2018; and

WHEREAS, the Denton Planning Commission has reviewed the proposed change in zoning classification and recommended approval of the change; and

WHEREAS, the Denton Town Council finds that it is in the best interest of the Town to amend the Official Zoning Map of the Town for the rezoning of such properties to General Commercial (GC); and

NOW THEREFORE, BE IT ORDAINED BY THE DENTON TOWN COUNCIL AS FOLLOWS:

<u>Section 1</u>: The Denton Town Code § 128-173 is hereby amended by repealing the Official Zoning Map of the Town of Denton bearing the date August 2, 2018, and adopting the Zoning Map attached hereto, bearing the date July 1, 2021, as the Official Zoning Map of the Town of Denton.

Section 2: In accordance with § C3-12 of the Denton Town Charter, this ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect seven (7) days from and after the date of its final passage and adoption, except that in accordance with Section 4-203 of the Land Use Article of the Maryland Annotated Code, this ordinance shall not be effective until at least ten (10) days after a public hearing is held.
