PROCEEDINGS

Call to Order:

The Planning Commission Meeting was called to order by Chairperson Walls at 6:00 p.m.,

on February 26, 2019, at the Denton Town Office and followed by the Pledge of Allegiance.

Approval of Minutes:

The January 28, 2019, Working Session Minutes were reviewed and approved

unanimously as submitted.

The January 29, 2019, Planning Commission Meeting minutes were reviewed and

approved unanimously as submitted.

Old Business #1 – Zoning Regulations for Chickens: The Planning Commission

reviewed the draft ordinance to allow chickens in the town of Denton prepared by Mr. Renshaw

and staff for consideration to forward to the Town Council.

Commissioner Cruickshank was satisfied with the proposed ordinance to allow chickens.

The detailed requirements in this ordinance will force Denton residents to be responsible and

accountable in keeping chickens.

Commissioner Mayer was in favor of the detailed application for chickens and the fact that

applicants will know their responsibilities as chicken owners.

Commissioner Quick was in favor of the proposed ordinance and application that addressed

all the issues and concerns that were discussed during the previous meetings.

Chairperson Walls requested another Joint Working Session with the Town Council during

the next regular Planning Commission Meeting on Tuesday, March 26th. The Planning

Commission should forward the proposed ordinance and application to the Town Council for

review and discussion at their next regular meeting.

Chairperson Walls is in favor of the proposed ordinance and application for keeping

chickens.

Chairperson Walls commended Mr. Renshaw for the thoroughness of his research in

drafting the proposed ordinance and application.

Further discussion included drafting a manual with instructions for residents keeping

chickens.

The Planning Commission is in favor of the proposed ordinance and application.

Commissioner Mayer motioned to forward the proposed ordinance for keeping chickens to

the Town Council for consideration.

Commissioner Quick seconded the motion. The motion passed unanimously (4:0)
