NOTICE OF DENTON TOWN ELECTION AND FILING BY CANDIDATES

Tuesday, November 3, 2020, 7 a.m. to 8 p.m.

There will be an election held this date for the purpose of electing one Town Council member, to fulfill a five-year term. All persons desiring to become a candidate for the Town Council shall have resided in the Town at least one year prior to election, shall be a registered voter of the Town of Denton, shall be at least 25 years of age, and shall file in accordance with the Denton Charter, Article V, Section C5-8 which reads in part as follows:

Candidates for election to the office of the Denton Town Council shall file with the Board of Supervisors of Elections a petition signed by at least twenty (20) registered voters of the Town of Denton. The candidate shall file the petition for an elective office not less than thirty (30) days, including Sundays and holidays, prior to the date of such election. Such petition shall state the name and address of the candidate, the fact that such person is eligible for election of the office of council, and that such person wishes his/her name placed on the ballot as candidate. Such petition shall be sworn to by the person filing same, both as to the fact of the candidate's eligibility and as to the genuineness of the signatures on such petition. The Board of Supervisors of Elections shall advertise the filing requirements once weekly for one (1) month prior to the filing deadline in a paper circulated in the Town. No person shall be eligible for elective Town public office who has not fulfilled the requirements of this Section.

A further requirement for candidates for election is found in Section 14-4 (D) of the Town of Denton Ethics Code. Petitions of candidacy will not be accepted by the Town of Denton or the Board of Election Supervisors unless the certificate is accompanied by a complete financial disclosure statement complying with the Town of Denton Ethics Code.

The petition of candidacy and the completed financial disclosure statement must be delivered to the Denton Town Office, at 4 N. Second St., Denton, by 4:00 p.m., Friday, October 2, 2020. It is suggested that the petition be returned several hours prior to the 4:00 p.m. deadline so the names of the signers of the petition may be verified as registered voters. This will provide ample time to obtain additional signatures should any of the signatures prove to be invalid. Petition forms have been prepared for the convenience of the candidates filing and may be obtained www.dentonmaryland.com or at the Denton Town Office during normal working hours (8:30 a.m. to 4:00 p.m., Monday through Friday except for holidays).

Chief Cox Retires September 1



After more than three decades in law enforcement, Denton Police Department Chief Rodney Cox is announcing his retirement. Chief Cox will step down September 1, 2020 after 25 years of service with the Denton Police Department.

The Chief started his law enforcement career with the Cambridge Police Department in 1985 where he was assigned to patrol. The Dorchester County Sheriff's Office hired him in 1988 and assigned him to the County Drug Task Force. Chief Cox then took a brief leave from police work and went to work for his father's business, but ultimately returned to his calling in law enforcement and joined the Denton Police Department in 1995. He was appointed Chief of Police in 1998, serving a nearly unheard of 22 years in that position. During his time with Denton Police, Chief Cox instituted many programs such as neighborhood watches, citizen police academies and a police Explorer program for aspiring officers. Chief Cox's primary vision was improving the quality of life for Town residents and for those who work in and visit Denton.

Chief Cox said today, "It has been an honor and privilege to serve the citizens of Denton for a quarter of a century. I hope and pray we have made a profound difference for those we serve and protect."

The Chief first shared the news with the Denton Town Council on June 22. Mayor Abigail McNinch said, "My fellow Council members and Town of Denton staff extend our deep appreciation Chief Cox's service to Denton and its residents. We wish him well after his illustrious and successful career. Chief, please enjoy your well-deserved retirement."

Chief Cox plans to enjoy time with his family, especially with the little one who calls him "Pop Pop", as well as spending time on the water boating and fishing. Please join us in congratulating him for a career well done!

Boat Ramp Permit Season

Boating season is here. Just a reminder, a permit is required to launch any vessel, via boat trailer, at all Caroline County boat ramps and public landings.

Permits may be purchased for one day use or annual use and vary in price.

A one day pass is \$10. Annual pass fees are \$25. Annual permits are valid only when displayed on the driver's side of the boat trailer tongue, within 12 inches

of the hitch. Daily permits must be hung on the inside mirror facing the windshield. Fines for a first offense are \$50, and a second offense is \$100.

Special Event Permit Updated

The town has updated their special event request form. This form is available online at www.dentonmaryland.com, click on "Road Closure and Special Event" and the form can be accessed there.

If you are looking to see if an event is coming within town limits that will close a road, this information is on the website as well, below the special event permit info.

If you would like to have a Special Event and need a portion of a street closed off, please fill out the form and return it to the Denton Police Department at 100 N Third St. Denton, MD 21629.

Organizations are strongly urged to carry general liability insurance for their event.

If you need printouts of signs for "face mask required" or "distancing reminders", this is available on the website as well.

Special Events may be

contingent on Governor Hogan's Executive Orders pertaining to event limitations during the COVID-19 Pandemic. Please check the Maryland.gov website for details and the Governor's most current orders.

Special Event forms should be turned in 30 days prior to your event. If your event is less than 30 days away, please contact the Denton Police Dept. first at 410-479-1414.

If you wish to use the Community Demonstration Garden at 4th and Gay St., please contact Denton Main Street at 410-924-2328.

Fall Loose Leaf Colletion

Autumn is here and the leaves are beginning to fall. The Denton Public Works Department is scheduling their annual loose-leaf vacuuming removal service to occur Monday November 2, 2020 through Monday December 14, 2020. Leaves must be bagged for pickup the remaining months of the year.

Loose leaf vacuuming will occur on Friday and/or Monday, pending workload, and excluding holidays. It will be necessary to call in your loose-leaf vacu-

um pickup request by 12 NOON on Thursday to guarantee pickup by Monday. We ask that you please only have one pile of leaves and have it located at the edge of your property, without obstructing sidewalks or roadways, where it can easily be accessed by Public Works.

Bagged leaf collection will still take place on Wednesday and must be called in to the Town Office by 12 NOON on Tuesday.

Citizens are encouraged to call the Town Office at 410-479-2050 to request pickup. If calling after hours please leave the request on the

Town Office answering machine, ext. 1.

Please follow these guidelines for leaf removal:

- Leaves should be raked to the curbside or allev.
- DO NOT rake leaves into the street
- DO NOT rake leaves onto the sidewalk.
- Make sure all sticks and limbs are removed from the pile of leaves.
 - Make sure there are no other objects or debris mixed with the leaves (like bottles, cans, flowerpots,

gloves, ashes, pet waste or other trash).

- Piles of leaves with sticks, limbs, or other debris will not be picked up.
- Phone in your pickup request to the Town Office at 410-479-2050 by Thursday to guarantee pickup by Monday.
- All pickups will be done by request/appointment only.
- Loose leaf pickups will occur from Nov. 2 through Dec. 14, on Mondays and Fridays only, except for holidays.

UTILITY BILL ALERT!

Utility bills will be mailed around October 1, 2020. To avoid having your water turned off payment must be received by October 25, 2020. Payments can be made in person Monday - Friday from 8:30 AM to 4:00 PM, by mail, or by placing it in the night drop box located to the left of the front door.

Acceptable payment methods include cash, check, money order or cashier check. You can also pay by credit card in the office. The next utility bill will be mailed around January 1, 2021 and will be due in full by January 25, 2021

Your Help Needed With Excess Trash

During this already difficult time of COVID19, trash tonnage has significantly increased, and we are asking for your help to reduce the overage. This extra cost is being absorbed by your current tax dollars instead of going to other things. If we can all work together, we can get back to pre COVID19 levels.

Please assist the Town by adhering to the following:

- Refuse containers must be water-tight, made of metal or plastic, with handles and tight-fitting covers.
- A maximum of 128 gallon per residence will be collected. This is equal to four 32 gallon or two 64-gallon wheeled waste containers.
- All trash must be securely bagged and fit inside the closed can.
- Only place household waste in the trash.
- Separate and collect all newspaper and cardboard. Please, call 410-479-2050 by Tuesday for (free) special collections pickup on Wednesday.
- Recycle as much as you can. The county's Holly Road site and the recycling bins behind the YMCA/Goodwill

at the Denton Plaza accepts glass, paper, cardboard, metal cans, etc. Please utilize this free drop off center if you can.

In addition, - Approved bulk items (list can be found on the Town website under the Public Works tab) will be collected Wednesdays with the purchase of a pickup ticket.

The Town now has a new Special Collections/Bulk Pick -Up form that can be printed from the town website and mailed, dropped off at the drive thru during business hours, or deposited in the night drop box located on the Second Street side of the Town Office, along with the payment of \$5 per item. NO NON-HOUSHOLD TRASH, **CONSTRUCTION** DEBRIS, LOOSE UNBAGGED TRASH, CARDBOARD OR TRASH OVER 128 GALLONS WILL BE PICKED UP.

Thank you for your cooperation in making Denton a better place to live. Also, please remember this is not the policy of the trash contractor, they are following our direction and existing town code. Please, refer all questions to Planning and Codes (410)479-3625.

TOWN OF DENTON VOTER REGISTRATION FOR ELECTIONS

All citizens of the Town of Denton that have not yet registered to vote must do so in order to be eligible to vote in the Denton November 3, 2020 Elections. Under the universal registration law which went into effect January 1, 1990, any person registered to vote in Caroline County automatically becomes eligible to vote in the Denton Town Elections, if qualified under the regulations set forth in the Town of Denton Charter which are as follows:

Every person who is a citizen of the United States, is at least eighteen (18) years of age, has resided within the corporate limits of the Town for thirty (30) days preceding any Town election, and is registered with the Board of Elections Supervisors for Caroline County, and registered in accordance with the provisions of this charter and town ordinances shall be a qualified voter of the Town. Transfers may be granted by the registration officials from one ward to another in said Town. No person shall be entitled to register on Election Day. Every qualified voter of the town shall be entitled to vote at any or all elections.

Voter registration is available Monday through Friday during normal working hours (9:00 a.m. to 4:00 p.m.) at the Caroline County Board of Elections, Caroline Health and Public Services Building, at 403 South Seventh Street, Denton. Forms may be requested by calling the election office at (410) 479-8145, completed and mailed to the Board of Elections Offices.

Chapter 10 - Elections, Article I - Absentee Voting

Applications to request an absentee ballot must be sent to the Town Clerk for receipt on or before:

October 16, 2020 if by mail October 30, 2020 if delivered in person

Absentee Ballot Applications are available on the Town's website at www.dentonmaryland.com

or at the Town Office located at 4 N. Second St. All request must be submitted in writing and

include the voter's name, residence address, signature of the voter, and the address to which the

ballot is to be mailed, if different from the residence address.

Once the Application for an Absentee Ballot is approved, the ballot and instructions will be mailed to the applicant two weeks prior to the election or hand-delivered to the qualified voter if the application is presented in person to the Town Clerk between October 16, 2020 and October 30, 2020.

All absentee ballots must be returned to the Denton Town Office, Attn: Supervisors of Elections, 4 North Second Street, Denton, Maryland 21629, before the closing of the polls (8:00 p.m., Tuesday, November 3, 2020). Instructions must be followed in order to be considered valid.
