# Register to Vote by October 1

All citizens of the Town of Denton that have not yet registered to vote must do so in order to be eligible to vote in the Denton November elections. Under the universal registration law which went into effect January 1, 1990, any person registered to vote in Caroline County automatically becomes eligible to vote in the Denton Town Elections, if qualified under the regulations set forth in the Town of Denton Charter which are as follows:

Every person who is a citizen of the United States, is at least eighteen (18) years of age, has resided within the corporate limits of the Town for thirty (30) days preceding any Town election, and is registered with the Board of Elections Supervisors for Caroline County, and registered in accordance with the provisions of this charter and town ordinances shall be a qualified voter of the Town. Transfers may be granted by the registration officials from one ward to another in said Town. No

person shall be entitled to register on Election Day. Every qualified voter of the town shall be entitled to vote at any or all elections.

Voter registration is available Monday through Friday during normal working hours (9:00 a.m. to 4:00 p.m.) at the Caroline County Board of Elections, Caroline Health and Public Services Building, at 403 South Seventh Street, Denton. Forms may be requested by calling the election office at (410) 479-8145, completed and mailed to the Board of Elections Offices.

PLEASE NOTE: The last date to register to vote in the Town of Denton November 2, 2010 election is Friday, October 1, 2010.

# **UTILITY BILL ALERT!**

Utility Bills will be mailed around October 1, 2010. # Wastewater Treatment Plant ENR Upgrade

Denton The existing Wastewater Treatment Plant is currently undergoing the Enhanced Nutrient Removal upgrade meet additional reductions nutrient pollutants under the 2000 Chesapeake Bay Agreement. Upgrading sewage treatment plants for nutrient removal is one of the top environmental priorities of the federal government and the states comprising the Chesapeake Bay watershed.

The Chesapeake Bay, vital to the economy and quality of life in Maryland, has experienced a decline in water quality due mainly to excess nutrients flowing into the Bay and its tributaries. The bay suffers from algae growth that blocks sunlight, kills seabed grasses, and creates oxygen-depleted zones. The U.S. EPA and the state governments are working on plans to establish pollution caps for nitrogen, phosphorus, and sediment flow into the bay. Funds are being allocated to upgrade treatment plants to meet the criteria.

Sewage treatment systems first appeared in the United States in the mid-1800s. Initially, wastewater plants collecting treatment wastewater from homes, industries, and businesses simply had to achieve primary/physical treatment by providing screens, grit removal units, and settling tanks. primary treatment succeeded in a 45 to 50% reduction of pollutants by eliminating easily removable materials. The Clean Water Act of 1972 established the National Pollutant Discharge Elimination System (NPDES), which permits and regulates all discharges to U.S. waterways. NPDES permits regulate discharges into navigable waters from all point sources of pollution, including industries, municipal wastewater treatment plants, sanitary landfills, large agricultural feedlots, and return irrigation flows.

Secondary treatment introduced the biological process in which microorganisms are used to metabolize and remove the organic material from the wastewater. Under carefully controlled conditions, the wastewater, microorganisms, and air are mixed. The microorganisms consume and break down the organic material, achieving 85-90% reduction in pollutants. As early as 1957, communities in Maryland received federal and State grants to upgrade their facilities with secondary treatment systems. However, secondary treatment was not required for most plants until the inception of the NPDES permit in 1972.

# NOTICE OF DENTON TOWN ELECTION AND

#### FILING BY CANDIDATES

Tuesday, November 2, 2010, 7 a.m. to 8 p.m.

There will be an election held this date for the purpose of electing one Town Council member for a five year term. All persons desiring to become a candidate for the Town Council shall have resided in the Town at least one year prior to election, shall be a registered voter of the Town of Denton, shall be at least 25 years of age, and shall file in accordance with the Denton Charter, Article V, Section C5-9 which reads in part as follows:

Candidates for election to the office of the Denton Town Council shall file with the Board of Supervisors of Elections a petition signed by at least twenty (20) registered voters of the Town of Denton. The candidate shall file the petition for an elective office not less than thirty (30) days, including Sundays and holidays, prior to the date of such election. Such petition shall state the name and address of the candidate, the fact that such person is eligible for election of the office of council, and that such person wishes his/her name placed on the ballot as candidate. Such petition shall be sworn to by the person filing same, both as to the fact of the candidate's eligibility and as to the genuineness of the signatures on such petition. The Board of Supervisors of Elections shall advertise the filing requirements once weekly for one (1) month prior to the filing deadline in a paper circulated in the Town. No person shall be eligible for elective Town public office who has not fulfilled the requirements of this Section.

A further requirement for candidates for election is found in Ordinance #206, Section 4, paragraphs a. and b. which reads in part as follows:

All elected Town officials in the Town shall file . . . a statement with the Commission disclosing any gifts received during the preceding calendar year from any person having a contract with the Town of Denton or any person regulated by any agency thereof. This statement shall identify the donor of the gift and its approximate retail value at the time of receipt.

Candidates for elective offices shall file statements consistent with the requirements of Subsection (a) of this section [above paragraph] at the time that they file their certificate of candidacy.

The petition for filing must be delivered to the Denton Town Office, 13 North Third Street, Denton, by 4:00 p.m., Friday, October 1, 2010. It is suggested that the petition be returned several hours prior to the 4:00 p.m. deadline so the names of the signers of the petition may be verified as registered voters. This will provide ample time to obtain further signatures should any of the signatures prove to be invalid. Petition forms have been prepared for the convenience of the candidates filing and may be obtained at the Denton Town Office during normal working hours (8:30 a.m. to 4:00 p.m., Monday through Friday except for holidays).

# The History of National Night Out

The National Association of Town Watch (NATW) is a nonprofit, crime prevention organization which works in cooperation with thousands of crime watch groups and law enforcement agencies throughout the country. Since 1981, NATW has been dedicated to the development, growth and maintenance of organized crime and drug prevention programs nationwide.

National Night Out, 'America's Night Out Against Crime,' was introduced by the Association in 1984. The program was the brainchild of NATW Executive Director Matt A. Peskin.

In an effort to heighten strengthen awareness and participation in local anticrime efforts, Peskin felt that a highprofile, high-impact type of crime prevention event was needed nationally. At that time, he noted that in a typical 'crime watch community', only 5 to 7% of the residents were participating actively. Due to the growth and success of these programs, he felt this percentage was too low. Subsequently, he proposed a national programwhichwouldbecoordinated

by local crime prevention agencies and organizations - but that would involve entire communities at one time. The first National Night Out was introduced early in 1984 - with the event culminating on the first Tuesday in August.

That first year, 400 communities in 23 states participated in National Night Out. Nationwide, 2.5 million Americans took part in 1984. The seed had been planted. In subsequent years, participation has grown steadily. The 26th Annual National Night Out last August involved 36.7 million people in 14,625 communities from all 50 states, U.S. territories, Canadian cities, and military bases worldwide. National Night Out 2010 will culminate on August 3. Over 15,000 communities are expected to take part. (Denton will celebrate on October 2, 2010 4p.m.-7:30p.m.) For more information, visit www. nationalnightout.org.

of 1983, signed by Maryland, Virginia, Pennsylvania, and the District of Columbia, specified a nutrient reduction goal of 40% by the year 2000. The Maryland Department of the Environment developed a strategy for achieving the desired reduction by the upgrade of the major 66 wastewater treatment plants, including Denton Wastewater Treatment Plant, to remove nitrogen through a process knownasbiologicalnutrientremoval (BNR). Using the BNR process, more than 90% of pollutants are removed, while achieving nitrogen concentration below 8 milligrams per liter (mg/l) total nitrogen.

Recognizing that more needs to be done, the Chesapeake Bay 2000 Agreement requires additional reductions of nutrient pollutants entering the Bay from all sources including sewage treatment plants. The Maryland Department

of the Environment is using the Bay Restoration Fund to upgrade with enhanced nutrient removal (ENR) technologies the 66 major wastewater treatment plants which discharge to the Chesapeake Bay. Once upgraded, these plants are expected to reduce nitrogen and phosphorus in the wastewater down to 3 mg/l total nitrogen and 0.3 mg/l total phosphorus, achieving approximately one-third of the needed reduction under the Chesapeake Bay 2000 Agreement. The ENR strategy builds on the success of the BNR removal program already in place.

The upgrade project at the Denton Wastewater Treatment Plant should be completed by July 2011.

# Fall Loose Leaf Collection

Autumn is approaching and soon the leaves will begin to fall. The Denton Public Works Department is scheduling their annual loose leaf vacuuming removal service to occur October 18 through December 13, 2010. Leaves must be bagged for pickup the remaining months of the year.

Loose leaf vacuuming will occur on Friday and/or Monday, pending work load, and excluding holidays. It will be necessary to call in your loose leaf vacuum pickup request by 12 NOON on Thursday to guarantee pickup by Monday.

Bagged leaf collection will still take place on Wednesday and must be called in to the Town Office by 12 NOON on Tuesday.

Citizens are encouraged to call the Town Office at 410-479-2050 to request pickup. If calling after hours please leave the request on the Town Office answering machine, ext. 25.

Please follow these guidelines for leaf removal:

\* Rake leaves to the curbside

or alley.

- \* DO NOT rake leaves into the street.
- \* DO NOT rake leaves onto the sidewalk.
- \* Make sure all sticks and limbs are removed from the pile of leaves.
- \* Make sure there are no other objects or debris mixed with the leaves (like bottles or other trash).
- \* Piles of leaves with sticks, limbs, or other debris will not be picked up.
- \* Phone in your pickup request to the Town Office at 410-479-2050 by Thursday to guarantee pickup by Monday.
- \* All pickups will be done by request/appointment only.
- \* Loose leaf pickups will occur from Oct. 18 through Dec. 13, on Mondays and Fridays only, except for holidays.

#### Loose leaf collection days:

- -November 1, 5, 8, 12, 15, 19, 22, 26, 29.
- -December 3, 6, 10, 13.

# Harriet Tubman Initiative Open House

We are a Chapter of the National Quilting Association (NQA). Last





# September Health Corner

I received in my office mail recently the American Cancer Society Cancer Facts and Figures 2010. Because we here at Wellness offer some cancer screening services I try and review the statistics thoroughly and still am very concerned with the lung cancer rates in the United States and Maryland. The amount of people who are smoking cigarettes/pipes etc. has been decreasing for the last several years which are great and our rates of new lung cancers and deaths from lung cancer are slowing down, however we are still having too many good people dying! As the American Cancer Society facts and figures book states, "Cigarette smoking is by far the most important risk factor for lung cancer"! I just try and think of a world without people having to suffer from lung cancer if somehow everyone would stop smoking. I mentioned in several of my past articles my mother and her battle with lung cancer. She never smoked a day in her life, but got it from secondhand smoke. I take her to University of

Pennsylvania's PENN Lung Center where I look at all the people in the waiting room suffering from lung cancer, emphysema, etc. Most are on oxygen, in wheelchairs and seem to use so much energy just to breathe! I hear them tell each other if I only knew what smoking would do to me, or if I only listened to my family when they told me to quit!

I truly understand in my almost 18 years here at the Health Department and working with clients that quitting smoking is one of the hardest addictions! I see clients try over and over and over again to quit smoking. However, we here at the Health Department are here to help and try to keep you from smoking. Our classes are FREE and we are able to give you the Nicotine Patches for FREE as long as we have a note from your physician that you can be on them. Absentee Ballots for Denton Election

Registered voters who wish to vote by absentee ballot during the Denton Town Elections on November 2, 2010 must request their absentee ballot by October 15, 2010, in accordance with the Denton Code.

Chapter 10, Article I, of the Denton Code reads as follows:

The following persons may vote as absentee voters in Town elections under this Article:

A. Any qualified voter in the town who may be unavoidably absent from the town for any reason on any town election day during the hours the poll is open.

B. Any qualified voter of the town whose physical disability confines him (or her) to his/her home or will otherwise prevent him (or her) from being present and personally voting at the polls on any town election day.

Chapter 10 (as amended by Ordinance #330) further reads:

A qualified voter of the town desiring to vote at any town election

as an absentee voter shall make application in writing to the Town Clerk for an absentee ballot, which application must be received not later than seventeen (17) calendar days before the election.

To make application for an absentee ballot: please include date of request, reason for request as indicated above, signature of applicant, and address of applicant and provide to the Town Clerk at 13 N. Third St., Denton, MD 21629 by October 15, 2010. Application forms are available at the Town Office.

Once the application for an absentee ballot is approved, the ballot will be mailed to the applicant two weeks prior to the election.

All absentee ballots must be returned to the Denton Town Office, Judges of Election, 13 North Third Street, Denton, Maryland 21629, before the closing of the polls (8:00 p.m., Tuesday, November 2, 2010) in order to be considered valid.



## **Attention Settlement Attorneys**

Reminder to all settlement attorneys and agencies to please contact the Denton Town Office for fees due to the Town when handling settlements for properties being sold or transferred within the Town limits. There may be water/sewer fees or miscellaneous charges that need to be collected at the time of settlement. This will keep the Town's records up to date and better serve the residents of the Town of Denton. This will also eliminate problems after settlement of any outstanding balances for the new property owner.

Please note: Any property that transfers ownership and the utility fees are not collected at settlement and forwarded to the town that result in the water being turned off for non-payment, the water turn on fee will still be charged. This charged may be passed on to the settlement attorney. Currently the fee to turn water service back on during regular business hours is \$50.00 and after 3:30 p.m., the fee is \$100.00. Forms are available to use when requesting information. Any questions, please call the Town of Denton at (410) 479-2050.

## **Service Fees for Utility Calls**

All calls for utility service for properties located in the Town of Denton are assessed the following service fee. This fee applies for all water shut off/turn ons, and other miscellaneous calls for service. Paying utility bills on time can help the property owner avoid these fees.

**Special Attention**: Any water that is turned off will be assessed this fee to have the water turned back on. Tenants will need to pay this fee before water service is turned back on. (This may not apply for emergency situations pending the nature of the call.)

# Updates on Ordinances and Resolutions

Ordinance #604 – An ordinance of the Town of Denton amending the Town Code to add Chapter 30 regulating Adult Oriented Businesses within the Town of Denton in order to promote public health, safety and welfare. Introduced 06/07/10, adopted 07/12/10, effective 07/22/10.

**Resolution #722** - A resolution of the Denton Town Council to amend the Town Charter by detaching certain territory located on the east side of the Town of Denton on the

eastern side of Pearson Road and the northern side of Foy Road, on the south side of Market Street, and on the west side on Mila Road, in the third election district, Caroline County, Maryland and consisting of 29.293 acres of land, more or less. NEVER ADOPTED.

**Resolution #726** – A resolution of the Town of Denton adopting the Town of Denton 2010 Comprehensive Plan. Adopted 07/12/10.

**Resolution #727** - A resolution of the Town of Denton approving a Public Works agreement and an inspection and maintenance agreement of private stormwater management facilities between the Town of Denton and Wal-Mart real estate business trust. Introduced 06/07/10, adopted 07/12/10.

**Resolution** #730 - A resolution authorizing the Town of Denton to establish a revolving working capital line of credit with Provident State Bank in the amount of \$450,000. Renewing annually. Adopted 07/12/10.

**Resolution** #731 - A resolution authorizing the Town of Denton to borrow funds from Provident State Bank to provide interim financing for the 5th Avenue Infrastructure project. Adopted 07/12/10.
