## Annual Drinking Water Quality Report

We're pleased to present to you this year's Annual Water Quality Report. This report is designed to inform you about the water quality and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water. Our water source is three (3) potable wells drilled at an average depth of 450 feet in the Piney Point Aquifer.

We have a source water protection plan available from our office that provides more information such as

## UTILITY BILL ALERT!

Utility bills will be mailed around October 1, 2023. To avoid having your water turned off **payment must be received by October 25, 2023.** Payments can be made in person Monday - Friday from 8:30 AM to 4:00 PM, online, by mail, at our drive-thru window, or by placing it in the night drop box located to the left of the front door.

Acceptable payment methods include cash, check, money order or cashier check. You can also pay by credit card at the office or online. The next utility bill will be mailed around January 1, 2024 and will be due in full by January 25, 2024. potential sources of contamination.

I'm pleased to report that our drinking water is safe and meets all federal and state requirements.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. ### TOWN OF DENTON VOTER REGISTRATION FOR ELECTIONS

All citizens of the Town of Denton that have not yet registered to vote must do so in order to be eligible to vote in the Denton **November 7, 2023** Elections. Under the universal registration law which went into effect January 1, 1990, any person registered to vote in Caroline County automatically becomes eligible to vote in the Denton Town Elections, if qualified under the regulations set forth in the Town of Denton Charter which are as follows:

Every person who is a citizen of the United States, is at least eighteen (18) years of age, has resided within the corporate limits of the Town for thirty (30) days preceding any Town election, and is registered with the Board of Elections Supervisors for Caroline County, and registered in accordance with the provisions of this charter and town ordinances shall be a qualified voter of the Town. Transfers may be granted by the registration officials from one ward to another in said Town. No person shall be entitled to register on Election Day. Every qualified voter of the town shall be entitled to vote at any or all elections.

Voter registration is available Monday through Friday during normal working hours (9:00 a.m. to 4:00 p.m.) at the Caroline County Board of Elections, Caroline Health and Public Services Building, at 403 South Seventh Street, Denton. Forms may be requested by calling the election office at (410) 479-8145, completed and mailed to the Board of Elections Offices.

# PLEASE NOTE: The last date to register to vote in the Town of Denton November 7, 2023 Election is Friday, October 6, 2023.

## **Special Collection Reminder**

**Household Items**: All special collection items to be picked up on Wednesdays must be called in by 12 noon on Tuesday. Effective January 1, 2003, there is a \$5.00 collection fee for each item to be collected. This fee must be paid prior to pick up date. Reminder that all mattresses and box springs must be wrapped in plastic and sealed with tape.

<u>Yard Waste</u>: All bagged leaf and brush pickup requests must be called in by 12 noon on Tuesday for Wednesday pickup. Call all requests in to the Town Office at **410-479** -**2050**. Leave a message after normal business hours.

## Fall Loose Leaf Collection

Autumn is here and the leaves are beginning to fall. The Denton Public Works Department is scheduling their annual loose-leaf vacuuming removal service to occur October Monday, 16, 2023, through Friday, December 15, 2023. Leaves must be bagged for pickup the remaining months of the year.

Loose leaf vacuuming will occur on Friday and/ or Monday, pending workload, and excluding holidays. It will be necessary to call in vour loose-leaf vacuum pickup request by 12 NOON on Thursday to guarantee pickup by Monday. We ask that you please only have one pile of leaves, and have it located at the edge of your property, without obstructing sidewalks or roadways, where it can easily be accessed by Public Works.

Bagged leaf collection will still take place on Wednesday and must be called in to the Town Office by 12 NOON on Tuesday.

Citizens are encouraged to call the Town Office at 410-479-2050 to request pickup. If calling after hours please leave the request on the Town Office answering machine, ext. 1.

### <u>Please follow these guide-</u> <u>lines for leaf removal:</u>

- •Leaves should be raked to the curbside or alley.
- •DO NOT rake leaves into the street.
- •DO NOT rake leaves onto the sidewalk.
- •Make sure all sticks and limbs are removed from the pile of leaves.
- •Make sure there are no other objects or debris mixed with the leaves (like bottles, cans, flowerpots, gloves, ashes, pet waste or other trash).
  - Piles of leaves with sticks, limbs, or other debris <u>will</u>
    <u>not</u> be picked up.
- Phone in your pickup request to the Town Office at 410-479-2050 by Thursday to guarantee pickup by Monday.
- All pickups will be done by request/appointment only.
- Loose leaf pickups will occur from Oct. 16 through Dec. 15, on Mondays and Fridays only, except for hol-idays.

## HOMESTEAD PROPERTY TAX CREDIT

To help homeowners deal with large assessment increases on their principal residence, state law has established the **Homestead Property Tax Credit**.

This tax credit limits the increase in taxable assessments each year to a fixed percentage. Every county and municipality in Maryland is required to limit taxable assessment increases to 10% or less. Applying for this credit could reduce your property taxes. In order to qualify for this credit you must be the property owner and must be the primary resident who lives there. This application only has to be <u>filled out one time</u> and is good as long as you live there and meet the requirements.

To help homeowners the State of MD has a program, <u>Homeowner's Property Tax Credit</u> which allows credits to be applied to a homeowner's property tax bill if the taxes exceed a fixed percentage of the person's gross income. It sets a limit on the amount of property taxes any homeowner must pay <u>based upon his or her income</u>. A new application must be filled out every year because it is income based. In order to be eligible for this credit you <u>must own the property and be your principal residence</u> <u>where you live at least 6 months of the year including</u> <u>July 1.</u>

## Service Fees for Utility Calls

All calls for utility service for properties located in the Town of Denton are assessed the following service fee. This fee applies for all water shut off/turned on, and other miscellaneous calls for service. Paying utility bills on time can help the property owner avoid these fees.

**Special Attention**: Any water that is turned off will be assessed this fee to have the water turned back on. Tenants will need to pay this fee before water service is turned back on. (This may not apply for emergency situations pending the nature of the call.)

We want our valued customers to be informed about their water utility. If you want to learn more, please attend any of our regularly scheduled Town Council meetings held on the first Thursday of each month at the Denton Town Office.

The Water Treatment Division of the Department of Public Works routinely monitors for contaminants in your drinking water according to Federal and State laws. This table shows the results of our monitoring for the period of January 1 to December 31, 2022. As water travels over the land or underground, it can pick up substances or contaminants such as microbes, inorganic and organic chemicals, and radioactive substances. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants. It's important to remember that the presence of these contaminants does not necessarily pose a health risk.

In this table, you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or Micrograms per liter - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000. Picocuries per liter (pCi/L) picocuries per liter is a measure of the radioactivity in water.

Action Level - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Maximum Contaminant Level - The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal - The "Goal" (MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

We're proud that your drinking water meets or exceeds all Federal and State requirements. We have learned through our monitoring and testing that some contaminants have been detected. The EPA has determined that your water IS SAFE at these levels.

All sources of drinking water are subject to potential contamination by substances that are naturally occurring or manmade. These substances can be microbes, inorganic or organic chemicals and radioactive substances. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. More information about contaminants and potential health effects can be obtained at the Caroline County Library or by calling the Environmental Protection Agency's Safe Drinking Water Hotline at 1-800-426-4791.

MCL's are set at very stringent levels. To understand the possible health effects described for many regulated contaminants, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-amillion chance of having the described health effect.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Denton Public Works is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components.

When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from the EPA Safe Drinking Water Hotline at 1-800-426-4791 or at http://www.epa.gov/safew ater/lead.

PFAS – short for perand polyfluoroalkyl substances – refers to a large group of more than 4,000 human-made chemicals that have been used since the 1940s in a range of products, including stainand water-resistant fabrics and carpeting, cleaning products, paints, cookware, food packaging and fire-fighting foams.

These uses of PFAS have led to PFAS entering our environment, where they have been measured by several states in soil, surface water, groundwater, and seafood. Some PFAS can last a long time in the environment and in the human body and can accumulate in the food chain.

Currently, there are no federal regulations (i.e. Maximum Contaminant Levels (MCLs)) for PFAS in drinking water. However, the U.S. Environmental Protection Agency (EPA) has issued a Health Advisory Level (HAL) of 70 parts per trillion (ppt) for the sum of PFOA and PFOS concentrations in drinking water. While not an enforceable regulatory standard, when followed, the EPA HAL does provide drinking water customers, even the most sensitive populations, with a margin

of protection from lifetime exposure to PFOA and PFOS in drinking water. Beginning in 2020, the Maryland Department of the Environment (MDE) initiated a PFAS monitoring program. The combined PFOA and PFAS concentration from samples taken from our water system in 2021, from all 3 of our Wells (TP02, TP04, TP05) with a result of NON-DETECT. MDE anticipates that EPA will establish an MCL for PFOA and PFOS in the near future. This would entail additional monitoring. To maintain a safe and dependable water supply we sometimes need to make improvements that will benefit all our customers. These improvements are sometimes reflected as rate structure adjustments. There will be an election held this date for the purpose of electing one Town Council member, to fulfill a five year term. All persons desiring to become a candidate for the Town Council shall have resided in the Town at least one year prior to election, shall be a registered voter of the Town of Denton, shall be at least 25 years of age, and shall file in accordance with the Denton Charter, Article V, Section C5-8 which reads in part as follows:

Candidates for election to the office of the Denton Town Council shall file with the Board of Supervisors of Elections a petition signed by at least twenty (20) registered voters of the Town of Denton. The candidate shall file the petition for an elective office not less than thirty (30) days, including Sundays and holidays, prior to the date of such election. Such petition shall state the name and address of the candidate, the fact that such person is eligible for election of the office of council, and that such person wishes his/her name placed on the ballot as candidate. Such petition shall be sworn to by the person filing same, both as to the fact of the candidate's eligibility and as to the genuineness of the signatures on such petition. The Board of Supervisors of Elections shall advertise the filing requirements once weekly for one (1) month prior to the filing deadline in a paper circulated in the Town. No person shall be eligible for elective Town public office who has not fulfilled the requirements of this Section.

A further requirement for candidates for election is found in Section 14-4 (D) of the Town of Denton Ethics Code. Petitions of candidacy will not be accepted by the Town of Denton or the Board of Election Supervisors unless the certificate is accompanied by a complete financial disclosure statement complying with the Town of Denton Ethics Code.

The petition of candidacy and the completed financial disclosure statement must be delivered to the Denton Town Office, at 4 N. Second St., Denton, by 4:00 p.m., Friday, October 6, 2023. It is suggested that the petition be returned several hours prior to the 4:00 p.m. deadline so the names of the signers of the petition may be verified as registered voters. This will provide ample time to obtain additional signatures should any of the signatures prove to be invalid. Petition forms have been prepared for the convenience of the candidates filing and may be obtained www.dentonmaryland.com or at the Denton Town Office during normal working hours (8:30 a.m. to 4:00 p.m., Monday through Friday except for holidays).
