ORDINANCE NO. 752

INTRODUCED BY:

AN ORDINANCE OF THE TOWN OF DENTON ADOPTING NEW OFFICIAL ZONING MAPS 01 AND 02 FOR THE TOWN OF DENTON

WHEREAS, the Town of Denton ("Town") is authorized by the Maryland Annotated Code ("Code"), Land Use Article, Section 4-204 to amend the Official Zoning Map; and

WHEREAS, the Official Zoning Map of the Town of Denton has not been updated and republished since July 1, 2021; and

WHEREAS, the Town of Denton has recently adopted a new Comprehensive Plan for the Town; and

WHEREAS, in accordance with the newly adopted Comprehensive Plan, the Town also proposes to adopt a new Comprehensive Zoning Map 01 and a new Overlay and Floating Zone Map 02 for the Town; and

WHEREAS, the Denton Planning Commission considered the revised Comprehensive Zoning Maps at its January 30, 2024, meeting and has recommended that the Town Council approve this Ordinance; and

WHEREAS, the Town Council held a public hearing on the revised Comprehensive Zoning Maps on March 7, 2024; and

WHEREAS, the Denton Town Council finds that it is in the best interest of the Town to adopt the Official Zoning Maps 01 and 02 of the Town for the rezoning of such properties for consistency with the adopted Comprehensive Plan on December 11, 2023; and

NOW THEREFORE, BE IT ORDAINED BY THE DENTON TOWN COUNCIL AS FOLLOWS:

<u>Section 1</u>: The Denton Town Code § 128-173 is hereby amended by repealing the Official Zoning Map of the Town of Denton bearing the date July 1, 2021, and adopting the Official Zoning Maps 01 and 02 attached hereto, bearing the date March 7, 2024, as the Official Zoning Maps of the Town of Denton.

<u>Section 2</u>: In accordance with Md. Code Ann., Land Use \S 4-203(b)(3), this Ordinance shall not be effective until at least ten (10) days after a public hearing


