Second Public Open House Planned for April 24 Residents Invited to View Preliminary Concept Maps

The Maryland Department of Transportation State Highway Administration is considering potential improvements along MD 404 (Shore Highway) between MD 16 (Harmony Road) and MD 16 (Greenwood Road) in Caroline County. A public open house was held in December, and a second public open house will be held 5:30 - 7:30 p.m. Wednesday, April 24, 2024, in the cafeteria of Denton Elementary School, 303 Sharp Road in Denton. You can view preliminary concepts for the MD 404 corridor at the April public open house and on the Project Portal page. Preliminary concept maps and a new survey will be posted online by the day of the public open house. Concepts are based on traffic and safety data, as well as public feedback from the 2023 online survey and results from the first public open house. At the April open house, study team members will be available to listen to your feedback and answer questions. The information from the open house will be used to identify concepts that may be recommended to move forward into preliminary design phase and help determine next steps. 
