Regular Meeting

Councilman Johnson made a motion to approve the minutes of the July 11, 2024 Regular Meeting as presented; seconded by Councilman Taylor. The motion passed with three votes. Councilman Lister abstained because he was not in attendance for the July meeting.

Public Hearing

Ordinance #753 - Stormwater Management Amendment

Mayor McNinch opened a public hearing at 6:03 PM to receive public comments on Ordinance # 753 - An Ordinance of the Town of Denton amending Chapter 106 Stormwater Management of the Denton Town Code.

Mayor McNinch asked for comments from the State: there were none.

Mayor McNinch asked for comments from the County: there were none.

Mayor McNinch asked for comments from the Council: there were none.

Mayor McNinch asked for comments from the Public: there were none.

Ordinances and Resolutions

Ordinance #753 - Stormwater Management Ordinance Amendment

An Ordinance of the Town of Denton amending Chapter 106, Stormwater Management of the Town Code.

Councilman Johnson made a motion to adopt Ordinance #753, seconded by Councilman Taylor.

In discussion: Mr. Scott Getchell, Town Administrator, provided a synopsis of the amendment, which includes stormwater design standard upgrades specific to helping improve the Poor House Run Water Shed. He shared that Riverkeepers has secured funding to remediate and restore the Poor House Run Watershed in Denton and by having new stormwater design standards in place, it will help to ensure the improvements will last.

Councilman Lister shared that he fully supports the amendment and understands the purpose, but he has concerns about the fiscal impact on current property owners when they decide to develop their properties.

Further discussion was held on design standard changes occurring frequently but being necessary for the betterment and safety of the community and the impact changes may have on future developments. The other side is that if nothing is done, then the properties along the Poor House Run will continue to be affected by stormwater runoff.

It was noted that the Ordinance becomes effective one year after adoption.

With no further discussion, Mayor McNinch asked for a vote on the motion to adopt.

The motion passed with 3 votes in favor, no opposed, however Councilman Lister chose to abstain.
