PROCEEDINGS

Call to Order:

The Planning Commission Meeting was called to order by Vice Chairperson Burroughs at 6:00 p.m., on February 25, 2025, at the Denton Town Office. Vice Chairperson Burroughs lead everyone in the Pledge of Allegiance.

This Meeting was made available to the public via Zoom Video Conferencing, and access to the meeting was made available on the Town website.

Approval of Minutes:

January 28, 2025, the Regular Meeting Minutes were reviewed and unanimously approved with one spelling correction noted on Page 10.

Old Business #1 - Caroline County Commissioners - Sharp Road Park - Minor Site

Plan:

Jamie Beechey, Director of Caroline County Recreation and Parks, (Applicant), and Tim Glass, Lane Engineering LLC, submitted a minor site plan for Lot 3, for the construction of a baseball field, softball field, multi-use field, and parking area for review by the Planning on January 28, 2025. At the January Planning Commission Meeting, a decision was deferred on the minor site plan pending further review of the following items:

- Full Photometric Lighting Plan of the entire area
- Obtaining letters of no objection from adjacent property owners for the Lighting Plan
- Interpretation of the Denton Town Code Lighting Exemptions §128-182.6

Mr. Glass provided the full photometric lighting plan for the Planning Commission as requested. The concerns about the lighting were addressed as the proposed lighting scheme does

not extend to the north or west sides of the property, and the light intensity is within the required

limits. The lighting plan demonstrates when the trees are removed from the north and west sides,

there is still no light spread. The light spread towards the east extends through approximately half

of Choptank Community Health System's lit parking lot. The undeveloped area, Parcel 2292,

which is zoned Regional Highway Commercial, experiences a minimal amount of light spread

onto their property. This light does not spill over onto the properties to the north.

Vice Chairperson Burroughs inquired about Mr. Glass's definition of light distance versus

light shadow.

Mr. Glass clarified that most jurisdictions utilize a footcandle measurement at the property

boundary. Denton's light ordinance impose stricter regulations, demanding a 0.1 footcandle within

ten feet of an adjacent commercial property line or 0.1 footcandle within five feet of an adjacent

residential property line. This measures the intensity of light that extends beyond the luminaire

directed downward and can be measured from the ground. At the pitcher's mound, this

measurement would equal 32 footcandles.

Mr. Glass submitted a letter of support from Choptank Community Health Systems

(Choptank) located on Parcel 2291 adjacent to the ballfields. Choptank has expressed support for

offsite parking and lighting for the ballfields. The property to the south, listed as GEM II Real

Properties, LLC, has been unreachable, and all available resources have been exhausted in

attempting to contact them. Mr. Glass also noted the lighting from this property would have a

minimal impact.

Mr. Glass is requesting approval of the minor site plan to construct a baseball field, softball

field, and multi-use field. The lighting plan presented includes a waiver for the lighting

requirements. The lighting intensity has been reduced from 50/30 to 30/20, decreasing the

Planning Commission Minutes February 25, 2025 luminaires. The light poles have been shortened to minimize light spillage, and the luminaires have

been designed with low cutoff and night sky compliance. Extended back shields have been

installed to prevent light from encroaching on neighboring properties.

Mr. Glass explained the lights will not be used for more than six months of the year and

will be operated manually. Lights will only be used if there is a game after dark and will be

manually turned on and off. The lighting will comply with the Town's noise ordinance, which

ends at 11:00 p.m.

Mr. Glass also requesting relief from the internal parking lot and landscaping requirements.

Twelve trees have been relocated to the outside of the parking lot.

Vice Chairperson Burroughs requested confirmation with Caroline County Parks and

Recreation regarding a designated time for the light cutoff.

Ms. Beechey clarified a misunderstanding from the prior Planning Commission Meeting.

Denton Little League has an 8:00 p.m. cutoff due to the absence of lights on their fields. With the

limited availability of ballfields, these new fields would provide more opportunity to be utilized

for games beyond 8:00 p.m. with the use of lights. She expressed a preference for the lights to

remain operational beyond 10:00 p.m. to accommodate potential doubleheader games that may

exceed anticipated durations. Caroline County is investing \$400,000 in the lights for the fields and

intends to utilize the lights for extended periods beyond an hour to maximize the County's

investment.

Commissioner Guay sought clarification on who would have control over the lighting

system.

Ms. Beechey informed the Commission that the lighting system can be accessed via lock

and key with Wi-Fi.

Planning Commission Minutes February 25, 2025 Vice Chairperson Burroughs requested that Mr. Glass address Peter Johnston's review

comments regarding the additional trees to be planted along the eastern border.

Mr. Glass responded that the bufferyard is attempting to eliminate one zoning boundary by

redefining another. He noted the adjacent properties are RHC (Regional Highway Commercial)

and currently lack a buffer. The park layout remains unchanged and would prefer to leave the

decision to the Planning Commission regarding whether to implement Mr. Johnston's suggestion

to add trees along the eastern side. Mr. Glass expressed a willingness to comply with the decision

subject to approval from Caroline County due to additional costs for the trees.

Alan Kampmeyer, an adjacent property owner, expressed concerns regarding the proposed

project. He questioned the accuracy of the computer-generated impact assessment and suggested

the need for real life measurements. There will be a loss of vegetative buffer due to the Stream

Restoration project and the potential negative impact of increased lighting on his property. Mr.

Kampmeyer recommended requiring actual measurements from the County for a more accurate

assessment and expressed dissatisfaction with the County's handling of the situation and suggested

prioritizing the concerns of local residents.

Commissioner Sorce inquired about the possibility of not lighting the softball field.

Travis Breeding, President of Caroline County Commissioners, stated they would like to

maximize the use of the complex if the Board approves. He assured the Board that the lights would

not pollute Mr. Kampmeyer's property. Mr. Breeding expressed fairness by allowing the softball

players to play under the lights and requested that both fields be lit.

Vice Chairperson Burroughs clarified that the field would only be lit during games.

Commissioner Guay asked for an estimate of the duration of lighting during the summer

months.

Mr. Breeding informed the Board the lights would be turned on around 8:30 p.m., and a

maximum of six Legion games may require lights until 11:00 p.m.

Mr. Breeding discussed the potential use of a new field for Little League and American

Legion Baseball games. It is estimated the field would be utilized for approximately 16 games

during the summer, with most games concluding by 10:30 p.m. The fields would be used less

frequently in the fall, with only one night per week dedicated to Legion games.

Kyle Bringman, President of Denton Little League, estimated the fields would be utilized

for approximately 16 games during the summer, with most games concluding by 10:30 p.m.

Commissioner Sorce inquired about the County's ability to provide a schedule for the

illumination of the field during games.

Mr. Breeding acknowledged the challenges associated with determining weather

conditions and other unforeseen circumstances to provide schedules.

Jane Roberts, an adjacent property owner, expressed her unwavering support for the

project. She presented the Board with a petition signed by thirty Town residents who advocate for

the installation of lights at Sharp Road Park.

Ms. Roberts and the residents believe the lights would enhance the safety of the community

at night. Her property is directly impacted by the proposed project, and she strongly advocates for

the installation of lights at the sports fields. She emphasized the dense foliage separating the field

from nearby homes provides a sufficient buffer from the lights and sound. She stressed the fields

would provide children with an opportunity to engage in sports rather than participating in

unsuitable activities.

Mr. Bringman reported a surge in participation, with a total of 281 children participating

in baseball and softball in Denton this year. He emphasized the significance of the County's

investment in local facilities and sent Mr. Getchell photographic evidence demonstrating a

minimal visual impact on nearby residences due to the existing foliage. The growing number of

teams require the need for additional fields. The league has experienced a doubling in size since

2019 and anticipates further expansion. He also highlighted the new rule permitting children aged

4 to 7 to play anywhere, which has resulted in an influx of players from neighboring towns.

Commissioner Guay expressed concern regarding the potential impact of the new rules on

the availability of other fields within the County for use.

Mr. Bringman clarified that the League is only permitted to utilize the fields within Town

for practices. Away games can be held on other fields within the County.

Shane Hansley, Coach and Coordinator for Denton Little League, provided further

clarification regarding the use of the smaller field. He stated it would primarily be utilized for

players aged 12 and under, who would not be playing late into the night.

Commissioner Guay inquired about the nature of the fields.

Mr. Bringham clarified that the fields would be grass fields.

Dan Mulford, Commissioner from Preston and President of Caroline County Softball,

expressed enthusiasm for the growth of softball and the urgent need for additional field space. He

emphasized the significance of providing opportunities for children to participate in evening

games.

The Commission reviewed the requests for the internal parking lot and landscaping

requirements and the additional trees to be planted on the northeastern border. The Commission

is in favor of the relocation of the parking lot trees and encourages the additional trees to be planted

on the northeastern border.

Commissioner Waterman motioned to approve the site plan as submitted and finds that the

proposed lighting plan for Sharp Road Park Facilities, as presented, demonstrates the park

facilities' location and public use along with the limitation on the hours and seasons of operation

and the intensity of projected light spillover, considering the existing and permitted uses of

adjacent properties constitute unusual circumstances. Additionally, the Commission acknowledges

that strictly enforcing the lighting standards outlined in § 128-182.1 would pose significant

challenges to the Applicant's ability to provide the intended recreational services. Therefore, the

Commission exempts the applicant from the lighting standards in § 128-182 as provided in § 128-

182.6 of the Denton Zoning Ordinance and to allow a variance for the trees as requested.

Commissioner Guay seconded the motion. The motion passed unanimously. (4:0)
