The Town of Denton is proud to partner with Solar Simplified to launch a townwide Community Solar campaign that helps you save money while supporting clean energy without any need to install panels or change your electricity provider.

We understand how rising costs for everyday services and products have placed burdens on our residents. That's why our Town Council has worked hard to lower property tax rates over the past few years while maintaining essential services and adopting a balanced FY26 budget. This Community Solar program is one more way we're working to provide relief and help families save where it matters most, on their monthly bills.

This initiative gives Delmarva Power residential customers the opportunity to join a local solar project and receive guaranteed savings on their electric bills. **At this time, the program is only available to Delmarva Power customers.** All participants will receive a guaranteed 10% discount on their monthly solar credits.

Once enrolled, your electricity will continue to be delivered by Delmarva Power, with solar credits applied directly to your monthly bill. This program is first-come, first-served and available until solar project capacity is filled.

Participation is completely free—there are no sign-up costs, no installation required, and no cancellation fees.

The first available solar projects are expected to go live by the end of the year. Now is the perfect time to lock in your spot, as space is limited.

Solar Simplified offers seamless consolidated billing—there is no second bill, and no credit checks or autopay required. Everything is handled directly through your existing Delmarva Power account, making the experience simple and transparent.

QUICK FACTS AND FAQ'S

What is Community Solar?	Community Solar, or Community Distributed Generation, is a government incentive program where electric supply customers virtually subscribe to receive solar energy credits from a solar farm located within their utility. Community Solar was created by New York State Energy Research & Development Authority ("NYSERDA") and is overseen by the New York Public Service Commission. Community Solar allows for all energy consumers in New York to support clean energy production. Visit NYSERDA's website to learn more.
Who is Solar Simplified?	Solar Simplified matches energy customers with local solar farms. Solar Simplified helps customers save money on their energy bill while supporting sustainable energy . Solar Simplified is registered with NYSERDA to help customers get discounts on solar credits from solar farms.
Subscription Service	You will become a member of a subscription service to receive solar energy credits. There is no need for the installation of panels on your roof or property . You will be sponsoring a portion of solar energy produced at a local solar farm based on your energy usage history. You will be billed for solar energy credits produced on your behalf. The solar farm will deliver the solar energy directly to your utility, and your utility will apply the appropriate solar energy credits to offset a portion of your electric bill each month. Any excess solar energy credits will carry over to your next month's utility bill, if applicable.
Subscription Term and Cancellation	Your subscription to receive solar energy credits as part of Community Solar will automatically renew monthly. There are no upfront costs to enroll! You simply pay as you go, with guaranteed 10% savings! If you are not 100% satisfied with your solar credit subscription, you may cancel for free at any time .
Billing	Each month, you will receive credits on your electric utility bill ("Utility Bill") based on the electricity generated by the project. Your subscription fee will be automatically taken from the credits you receive on your Utility Bill. Your subscription fee is equal to 90% of the value of the credits you receive each month. After the credits are reduced by the subscription fee, you will receive savings equal to 10% of the credits you receive. Customer is responsible for paying all Utility Bills in full, including the Basic Service Charge, Generation Charge, Transmission and Distribution Charges, and all applicable taxes.
Guaranteed Savings	Solar Simplified has arranged for you to receive the cost of solar energy credits at a guaranteed savings of 10% , meaning you only pay 90% of the cost of solar energy credits to be applied to your utility bill. Example: Your allocation of solar production is 1,000 kWh of solar electricity and the value of solar energy credits that month is \$.10/kWh. You would receive a credit on your utility bill of \$100 (the solar allocation multiplied by \$.10/kWh) and a 10% discount from Solar Simplified, paying only \$90.
Solar Farm	The solar panels producing and delivering solar electricity to your utility are located in New York State and in a zone served by your utility. Solar electricity production at each solar farm varies depending on the number of panels, exposure to sunlight, weather, slope of the land, and other factors. The amount of Solar Credits allocated to Customer shall be a percentage of the solar electricity produced and not consumed at the Solar Farm and shall be no more than Customer's historic electricity usage on an annual basis.
Utility Service	Your utility, or your current alternative electricity supplier, will continue to supply and/or deliver electricity to you without any interruption to your service.
