



TOWN OF DENTON Application for an Absentee Ballot 2026 Elections

Anyone registered to vote in Maryland, who resides in the Town of Denton can vote by absentee ballot, which lets you vote in an election without going to a polling place.

You can register to vote in Maryland online at elections.maryland.gov/voting.html or at your local election office, HAPS Building, 403 S. 7th Street, Suite 247, Denton, MD.

How to ask for an absentee ballot

- Fill out this form and get it to the Denton Town Office before the deadline.

How will you receive your absentee ballot?

- On this form, you choose how you want to receive your ballot: through U.S. Mail, or
 - You can also pick it up in person, or have someone pick it up:
 - If you want someone to pick up your ballot for you, you need to provide a Town of Denton Designation of Agent form. Get this form at the Denton Town Office or online at www.dentonmaryland.com.
 - The person who picks up your ballot must be at least 18 years old and cannot be a candidate on your ballot, cannot be your employer, or an agent of your employer, or officer or agent of the voter's union. You can also have this person return your voted ballot to the Town Board of Supervisors of Elections. This person must sign a form to show that he or she handled the ballot properly.

Deadlines for returning this form

Your deadline depends on how you send in this form, and on how you want to receive your ballot.

Denton Town Council Election: To request an absentee ballot by mail, application must be submitted to the Town Clerk by Friday, October 16, 2026 by 4:00 p.m. Requests in person will be accepted up until 4:00 p.m. on Friday, October 30, 2026.

Registration must be filed by October 2, 2026.

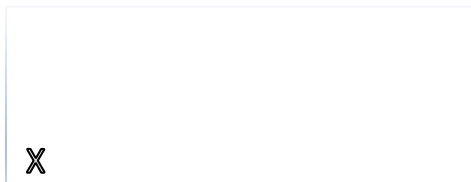
